7 or abandon federal authority over management of fish or game within the boundaries
8 of the state; and

9 (2) with which the federal government may contract to administer
10 federal authority over management of fish or game within the boundaries of the state.

11 (d) Notwithstanding any other provision of law, a state agency or employee
12 may not engage in police activities or other law enforcement activities to enforce a
13 federal law that preempts or supersedes state management of fish and game. This
14 subsection does not apply to assistance provided to a federal law enforcement officer
15 by the Department of Public Safety that is necessary in the unforeseen absence of
16 available assistance from a federal source, regardless of cost, to avert a present and
17 substantial risk of physical harm to a person.

This creates a direct conflict with federal law and federal management authority and will undoubtedly provoke judicial challenges to the legislation. Lawsuits of this nature, i.e., involving state/federal conflicts, are normally lengthy and expensive and will have a direct, but currently unpredictable, financial impact on the department.



SPONSOR STATEMENT

FOR SENATE BILL 128

"AN ACT RELATING TO THE STORAGE TANK ASSISTANCE FUND"

Senate Bill 128 allows the legislature to appropriate money from the storage tank assistance fund for projects relating to governmental fuel storage tanks and converts the existing grant program to a loan program.

No other state has a grant program and providing grants to private entities for cleanup of their storage tank facilities does not make fiscal sense. Many states do have loan programs and providing an affordable loan program to private entities for the purpose of cleaning up problematic private fuel tanks is much more fiscally responsible. Dispensing loans instead of grants also encourages private entities to take greater care during the initial installation of fuel storage tanks.

Enclosed is the CS you requested.

As you requested, I have removed the "~~any purpose~~" language from AS 46.03.410(a), as amended in SB 128. However, its removal has no legal effect. With or without that language, the legislature could appropriate any money in the storage tank assistance fund for any public purpose.

According to DEC, there are no pending applications under AS 46.03.415 (tank tightness and site assessment incentive program) and the application period has expired, so this draft repeals that statute and references to that statute.

This draft enacts new sections, AS 46.03.421 and 46.03.431, to replace the current grant programs that do have pending applications (AS 46.03.420 and 46.03.430) with loan programs. I believe I have retained in this draft the provisions that DEC said on the telephone were important to retain from the repealed statutes. However, DEC has not seen this new draft so, if their view is important to you, you may want to have them review the draft to ascertain whether we communicated well on that subject.

If you want me to send a draft to DEC or if I can be of other assistance, please let me know.

This bill proposes to replace the cleanup grant program with a loan program. The Department will incur additional operating costs in the administration of a loan program. Estimates for loan administration are \$45.0 the first year, \$75.0 the second year, and \$105 thereafter. These extra costs would cover only the loan examination, award, and collection of repayments and delinquent payments. Department staff would still approve the workplans and eligible costs and oversee the cleanup project to completion. These added costs assume that about 30 loans will be made per year for a total \$2.0 million per year.

In addition, the Department would need to add one Environmental Specialist to work with the Attorney's General Office on liability issues surrounding sites where owners choose not to participate in the loan program or are unable to qualify for a loan but must still clean up their site. Costs associated with the position include \$2.0 in travel costs to visit sites that require state lead cleanup action, \$10.0 in contractual costs

SB 128 changes the storage tank assistance fund from a predominately grant program to a loan program. This change would take effect July 1, 1999.

The change from a grant to a loan program would create both initial startup costs and ongoing costs for the Department of Law. During the first year of the loan program, Department of Law expenses would involve development of complex regulations and forms dealing with loan program eligibility and administration. We would expect that some entities that would have qualified for a grant will not be able to qualify for a loan due to lack of collateral. These entities may find it difficult or impossible to bring their facilities into compliance; therefore, an increase in the demand for environmental enforcement actions and compliance agreements is expected. We would also expect a high default rate among

loan recipients resulting in a continuing need for collection efforts. Collection efforts will be complicated by liability issues because the loan collateral may still be contaminated at the time of loan default.

This fiscal note does not address issues that may arise because of technical problems in the current draft of the SB 128. The department has been informed that a new draft addressing many of those technical issues is presently under development.

The new workload generated by this bill would be split between the Civil Division's Commercial and Environmental Law sections, with Commercial handling loan issues and Environmental Law the environmental compliance issues. In the first year, three-quarters of an attorney position would be required, with the work equally divided between the sections. In the second, and subsequent years, once regulations development and other initial start-up work is complete, a half-time position is expected to be sufficient, and the workload to primarily fall on the Commercial section (75 percent of the half-time position).

Fiscal note costs are based on the department's FY00 standard full-time equivalent attorney cost schedule (\$133,926), and include clerical support, communications, space, supplies, data processing, and other normal overhead expenses. An additional \$6,500 for one-time equipment purchases, costs that cannot be included in the rate as overhead, are added in FY00 only, and as a practical matter, placed in Commercial with the new part time position. These costs would be split between the separate components as follows:



I. INTRODUCTION

Preface

Leaking underground storage tanks have impacted a number of public drinking water systems in Alaska and pose a significant threat to human health and the environment. Over 50 percent of all pre-1998 UST systems in Alaska leaked over time, impacting soils and groundwater.

A. Statement of Purpose

On June 7, 1990, the Governor of Alaska signed into law House Bill 220 which amended Alaska Statutes Title 46, Chapter 3. Effective on September 5, 1990, this new law is commonly referred to as the "Underground Storage Tank (UST) statute." Among the provisions in the statute, the Storage Tank Assistance Fund was established to provide technical and financial assistance to tank owners and operators in an effort to prevent new spills and cleanup old spills. The following annual report to the legislature is submitted pursuant to Alaska Statutes Section 46.03.410.

B. Federal Law

The 1984 Hazardous and Solid Waste Amendments to the Resource Conservation and Recovery Act (RCRA) require, in part, that the U.S. Environmental Protection Agency (EPA) regulate USTs containing petroleum and hazardous substances. EPA estimates several million USTs nationwide contain petroleum or hazardous substances, tens of thousands of which are leaking. The resultant contamination of groundwater threatens a major source of the country's drinking water.

Congress directed the EPA to develop regulations for the design, construction, and installation of new tanks, as well as the addition of leak detection, corrosion

prevention, and spill and overflow protection to existing tanks. The EPA regulations went into effect on December 22, 1988. USTs installed on or before that date are considered "existing tanks," and those tanks installed after that date are considered "new installations." New installations must meet the performance standards set out in the regulations at the time of tank installation. Existing tanks were allowed to phase in these standards over a period of 10 years.

Congress also mandated that all UST owners, except state and federally owned or operated tanks, be able to demonstrate specific levels of financial responsibility for corrective action and cleanup associated with releases from their USTs, including third party loss and bodily injury. The most common type of financial responsibility is commercial pollution insurance.

The financial responsibility requirements were phased in according to the type of owner and the number of tanks owned; the final date for most tank owners to meet this requirement was December 31, 1993. Indian tribes owning USTs on Indian lands have until December, 1998 to comply. Most tank owners are required to demonstrate \$1 million of financial responsibility per occurrence and \$2 million aggregate. Failure to meet the requirements may result in fines of up to \$10,000 per day.

C. State Law

It was primarily due to the EPA's 1998 UST regulations that the Alaska legislature introduced the Alaska UST Legislation. During the legislative process, the EPA informed Alaskan lawmakers that federal budget cutbacks would prevent the agency from providing owners with technical assistance for complying with the newly mandated performance requirements. The

EPA program would consist of enforcement only, and failure to meet performance standards could result in fines of \$10,000 per day. The EPA may authorize state to implement their own UST program in place of the federal requirements if the state's requirements are "no less stringent" than EPA's and provide for adequate regulatory enforcement.

It was evident to lawmakers that Alaska businesses covered by EPA's UST regulations would be hard pressed to meet the new standards. They also recognized that the regulations governing underground storage tanks systems might not be easily understood by the public. Rather than relying solely on an en-

forcement program after problems developed, the legislation passed as HB 220 provides technical and educational assistance as well as incentives for compliance with federal and state requirements by: setting performance standards for both new and existing UST systems; providing for corrective action activities and cleanup standards for leaking USTs; mandating that the Department provide educational assistance to UST owners and operators; requiring the certification of UST workers; requiring registration of all USTs by owners or operators; establishing a Board of Storage Tank Assistance; and providing guidelines for the administration of the Storage Tank Assistance Fund.

D. Storage Tank Assistance Fund

The Alaska legislation establishing the Storage Tank Assistance Fund made funds available for program implementation, staffing, and administration of the following financial assistance programs: reimbursement incentives for tank tightness testing or site assessments (AS 46.03.415); grants and loans for risk assessment, containment, corrective action, and cleanup costs (AS 46.03.420); and grants for tank system upgrades and closure (AS 46.03.430). Table 1 (Summary of UST Financial Assistance), briefly describes the eligible costs and the assistance provided in each of these programs.

Pursuant to legislation, the Department promulgated regulations (18 AAC 78) on the general requirements for financial assistance eligibility, ineligible costs, project priority ranking procedures, application requirements, conditions of financial assistance, and grant payment procedures.

House Bill 513, signed into law on June 9, 1994, modified the UST law by establishing a December 30, 1994 application deadline for the closure and upgrade program, and extended the application period for cleanup assistance for those applicants who have met the closure/upgrade deadline or those who are already on the closure/upgrade waiting list. To be eligible for

this extension, the spill must be reported by July 1, 1996 and must have occurred before December 22, 1993.

Following are the annual appropriations to the Storage Tank Assistance Fund since inception:

For fiscal year 1998, the Fund was budgeted for the first time as a Capital Project rather than under the Operating Budget, recognizing the fact that site remediation, tank upgrade, and closure projects particularly with the short Alaskan construction seasons and long term nature of the projects, are more appropriately budgeted to capital projects than an annual operating budget.

V. PROJECTED COSTS AND UNFUNDED REQUESTS

As reflected on Table 6, 559 unfunded requests from all programs which will remain after FY 99 funding for a total of \$32.9 million in unfunded requests. In order to adequately address the total estimated costs for financial assistance requests, in addition to considering

the projected financial assistance for FY 99, it is necessary to summarize unfunded requests from the following categories:

A. Prior Unfunded Requests:

A total of 559 applications submitted in previous years for the cleanup, upgrade, and closure programs will remain unfunded after the FY 99 funds are used. In addition, 158 applications were made to the Reimbursement Program by the deadline on March 5, 1991 requesting \$3,388,437 for cleanup, closure or upgrade activities occurring on or after December 22, 1988 and before September 5, 1990. These reimbursement requests will not be funded in the foreseeable future.

When making its annual allocation to the grant programs, the Board of Storage Tank Assistance is required to consider work completed under the Reimbursement Program as the lowest priority for reimbursement. By statute, the reimbursement program may be funded only when all eligible requests for funding in the other categories have been satisfied in a given fiscal year, and since requests for upgrade, closure, and cleanup grants have exceeded available amounts, no funds have yet been allocated to the reimbursement program. Appendix F lists the applicant's name, the facility name, and the amount requested from the Reimbursement Program.

B. Continuation of Cleanup Activities

Tank cleanups are funded according to a phased approach so that a number of cleanup projects will continue to require funding the following fiscal year. Currently it is projected that 30 facilities will require continued funding for an estimated \$950,000 during FY 99. Table 5, Page 11.

If funding levels remain insufficient to meet the demand described above, the Department will continue to fund the higher priority ranked projects while keeping unfunded requests on file until such time that funding becomes available.

VI. PROGRAM SUMMARY SINCE INCEPTION

From the inception of the Underground Storage Tank Financial Assistance Program on September 5, 1990, until December 31, 1997, over \$22 million have been expended in grants and loans to pay a portion of the costs of tank tightness testing, site assessment, cleanup, upgrade or closure. Of the over 2,000 applications received, 846 have already received funding, with up to 158 upgrade and closures expected to be funded this year. The remainder of the applications are awaiting funds or are ineligible.

Table 7 lists all activity for applications received for all programs since program inception through December 31, 1998. The number and dollar amount of applications received, applications funded in prior years, applications anticipated to be funded and ineligible applications are summarized on the table. The largest amount of funds disbursed is over \$15 million for tank

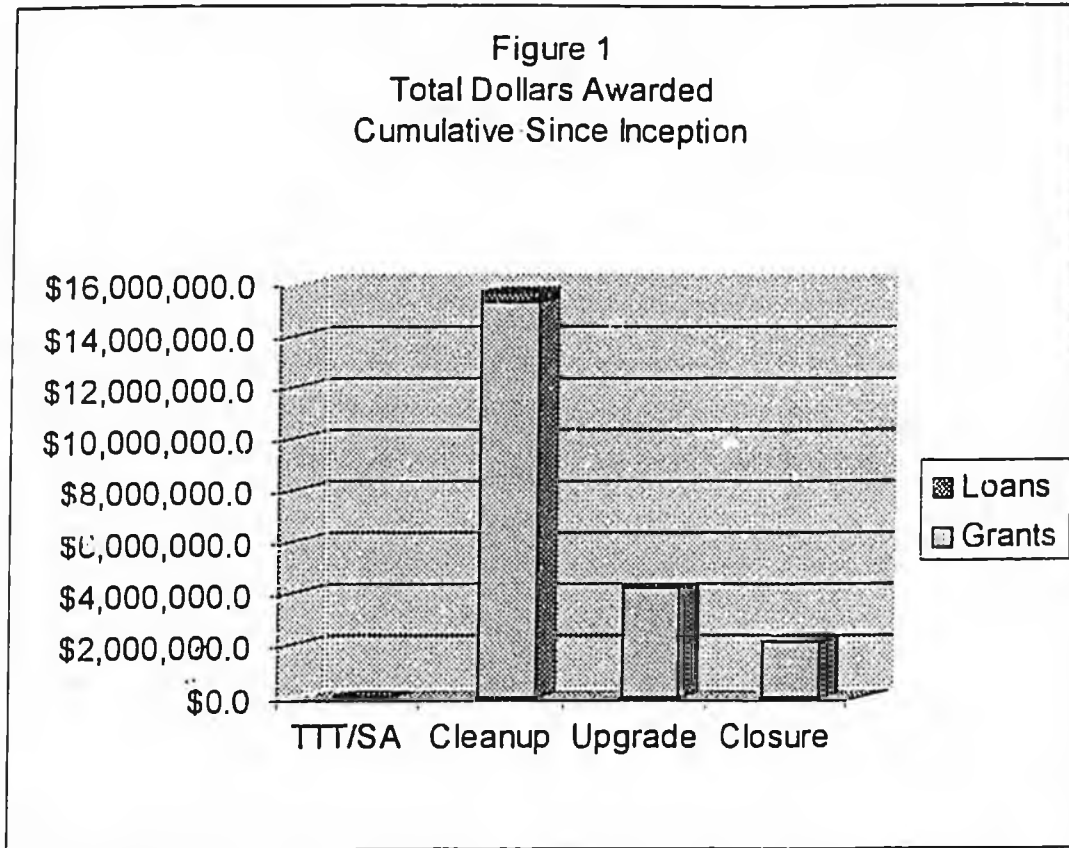
cleanup grants and loans while the largest number of grants expended has been tank tightness testing or site assessment at 286 facilities.

As reflected below and in Table 6, a total of 559 unfunded requests (527 waiting for funds and the 32 continuation cleanup projects) will require future funding.

Figures 1 and 2 are graphic representation of the data in Table 7.

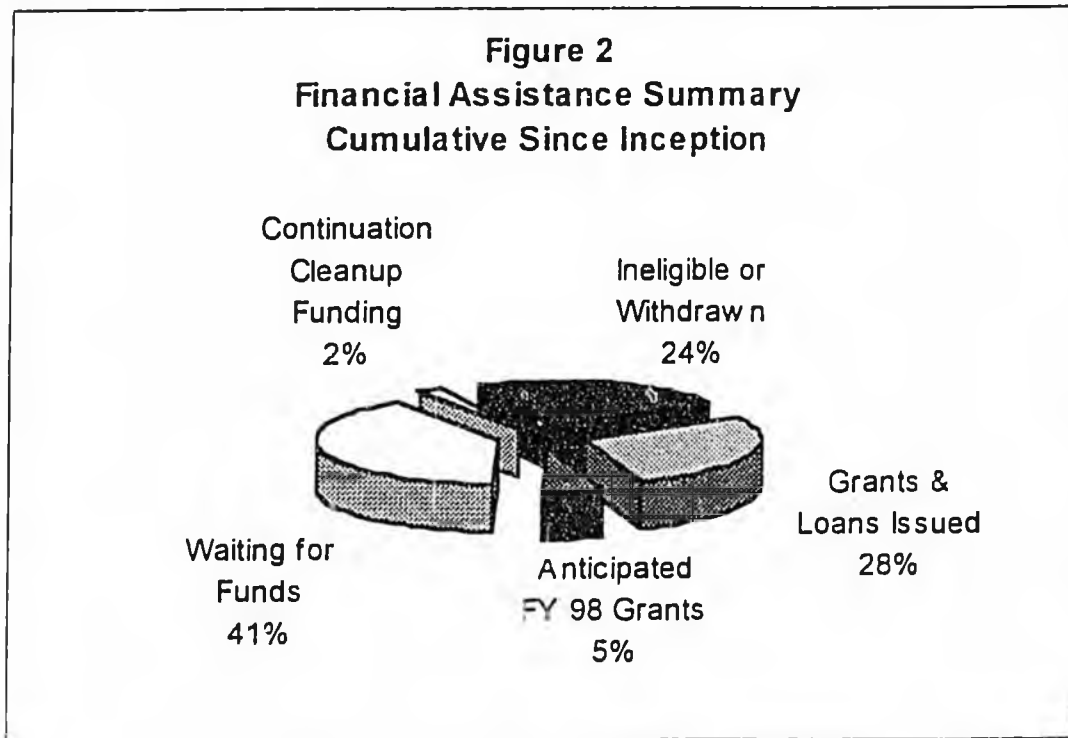

CSSB 128 (RES) changes the storage tank assistance fund from a predominately grant program to a loan program. This change would take effect July 1, 1999.

The change from a grant to a loan program would create both initial startup costs and ongoing costs for the Department of Law. During the first year of the loan program, Department of Law expenses would involve development of complex regulations and forms dealing with loan program eligibility and administration. We would expect that some entities that would have qualified for a grant will not be able to qualify for a loan due to lack of collateral. These entities may find it difficult or impossible to bring their facilities into compliance; therefore, an increase in the demand for environmental enforcement actions and compliance agreements is expected. We would also expect a high default rate among
