On behalf of the Senate Finance Committee, I request that you schedule Committee Substitute for Senate Joint Resolution 43, "Requesting the United States Congress to grant a two-year moratorium on requirements for certain state payments under federal programs", for a hearing in the Senate State Affairs Committee at your earliest convenience.

The maintenance of effort requirement for certain federally funded programs denies Alaska and other states the opportunity to reduce or reallocate state expenditures.

Committee Substitute for Senate Joint Resolution 43 asks Congress to give Alaska and other states the flexibility to develop budgets that address and meet important needs as they currently exist.

#### Committee Substitute for Senate Joint Resolution 43

**“Requesting the United States Congress to grant a two-year moratorium on state maintenance of effort requirements for federally funded programs.”**

Committee Substitute for Senate Joint Resolution 43 requests that the United States Congress grant a two-year moratorium on maintenance of effort requirements on states receiving federal funds..

Alaska is facing a serious “fiscal gap.” Federal requirements for maintenance of effort for federally mandated programs inhibit the states ability to reduce or reallocate state expenditures.

This resolution, if granted, would give states more flexibility to adjust their budgets to appropriate levels without losing federal funding
