

Consider an amendment to HB 426 that would add a high asset test to the poverty-level pregnant women Medicaid eligibility group. The asset level might be something like \$20,000, or some other amount that was high enough for the state to assume the pregnant women had enough resources to pay for her own prenatal care and delivery. The asset level would have to be high enough that

- (a) truly needy pregnant women are still going to be eligible;
- (b) Division of Public Assistance caseworkers are able to use less intrusive verification policy when it was obvious that a pregnant woman does not have assets close to the limit; and
- (c) pregnant women who have enough assets to cover their own prenatal and delivery care, are required to pay for that care even though they may have limited income.

The federal **Deficit Reduction Act of 2005** (DRA 2005), signed into law February 8, 2006, includes many mandatory rule changes related to determining financial eligibility for long-term-care related Medicaid. Four of the changes are significantly more restrictive than current policy. You may be interested in using HB 426 to support the department's implementation of these new requirements, including a decision on #8 below. Addressing these rule changes in legislation will help get the word out that these new rules are coming and show the Legislature's interest in controlling Medicaid costs.

5. **Transfer of asset penalty period.** Instead of starting the penalty period beginning with the date of transfer, this new law requires the penalty period to start with the date of application for Medicaid. This will eliminate almost all instances when an individual escapes serving a penalty period because the penalty period has already run its course before the Medicaid application is submitted.
6. **Transfer of Assets:** The DRA 2005 also requires states to impose any partial months of ineligibility determined following a transfer of asset for less than fair market value. This means that many transfer of asset penalties will be one month longer than they would be under existing rules. More importantly, it eliminates the loop-hole that some exploit by purposely transferring assets piece meal so that they never amounted to a full month of long-term care costs and, therefore, they never have a penalty to serve. Over time these small transfers can add up to a significant asset being transferred.
7. **Annuities:** A restatement of the annuity changes in the DRA 2005 would support the department in our efforts to implement these changes. This is particularly true of the provision that requires the state of Alaska to be named as the remainder beneficiary in the first position for at least the total Medicaid paid on behalf of the annuitant. Prior to the passage of the DRA 2005, I included a similar provision in the proposed eligibility regulations. One of the public comments received included a threat of legal action if we went through with it. We now have the

benefit of the DRA 2005, but I would be helpful to have the explicit backing of the Legislature.

8. **Limit on the value of a home:** Normally, a person's home is an exempt resource for Medicaid eligibility purposes. The DRA 2005 actually puts a limit on the value of a home that would still qualify for this exemption. In effect, an individual will be ineligible for Medicaid if their home has an equity value for more than \$500,000, unless they sell it, borrowed against it, or take out a reverse mortgage to reduce the equity. The DRA 2005 actually gives the state a more liberal option of increasing that equity value to \$750,000. Your bill could determine the equity amount that Alaska will recognize.
9. **Health insurers required to work with Medicaid:** Section 6036 of DRA 2005 includes a mandate that states have a law requiring health insurers to cooperate with the state by (1) providing requested information on individuals they insure, (2) accept the State's right of recovery and assignment of rights, (3) responding to inquiries about claims they have paid, and (4) not denying claims submitted to them by the State within 3 years. Legal review will be needed to determine exactly what kind of statutory amendment is needed, but HB 426 would be an appropriate vehicle to put this amendment forward. This change will improve the chances that health insurance is used to the fullest extent before Medicaid is used.

DHSS Action Already in Progress

Even though legislation is not required, you may be interested in what the department is already doing to address some of the issues around children in residential psychiatric treatment centers (RPTC) and other residential settings. The Division of Behavioral Health is currently evaluating and testing through pilot projects the InterQual Behavioral Health Decision Support Tool, which will help the department assess the degree of need for children and adolescents referred for treatment in an RPTC. Using this nationally-normed "decision tool" prior to authorizing any Medicaid payment for treatment services out-of-state will result in consistent clinical decision-making around levels of care and appropriateness for treatment. When applied during the prior authorization process, InterQual will result in placement decisions better able to meet the child's needs and will minimize inappropriate level of care placements. InterQual has demonstrated that it is especially useful at the top end of the spectrum: i.e., acute care, sub-acute care, partial hospitalization. The department anticipates full implementation of this tool in calendar year 2006.

Testimony Re: House Bill 426
Comments to CS for House Bill No. 426

My name is Clover Simon, I am a social worker. I am currently not practicing social work in the State of Alaska but have extensive experience working with high risk youth in Washington State, most of whom were not living with their parents.

The changes reflected in the CS version of HB 426 have greatly improved this bill and I appreciate all the work that has gone into making this bill something that will not create a barrier for youth getting the medical care they need.

The one remaining concern I have is with Section 7 letter (j) and (k). This section does insert exception language that would allow a minor to apply and receive medical benefits without parental consent, which I feel is important. The issue is that the exception is vague and leaves the decision up to the "department" I assume this would be the person reviewing the application. Whether or not a youth can get confidential services is then at the discretion of the "department". On one hand you may have an employee who is an advocate for youth and can recognize that a youth applying for benefits on their own must have compelling reasons. Or you could get an employee who doesn't believe that youth should ever do anything without parental consent regardless of the situation. This section appears to be very subjective and my worry is that the confidentiality of youth will not be protected.

In my experience, youth who do not involve their parents have very compelling reasons. Navigating the medical assistance system is not easy and most youth are not going to choose to follow through without a parent or guardian unless there are extenuating circumstances. The percentage of youth who will be affected by this bill is likely small, but chances are they are the most vulnerable youth of our communities and deserve to have access to medical care with or without parental participation. I don't feel that leaving it up to individuals in a department will adequately protect youth.

I fully support that parents should be involved and responsible for their children, however I have worked with enough high risk youth to recognize that there are unfortunately many parents out there who are not. Youth who live in these types of situations or live outside the home should be given the opportunity to care for themselves by applying for medical assistance. I am worried that the subjective nature of this exception will close the door for many youth who are in need of services.

I urge you to look at this section and allow youth to apply for medical assistance without parental consent. Or for other support systems to assist them without parental consent (section 7 letter j). Often youth have found other support systems to replace dysfunctional parents and these adults should be able to assist a youth in getting the medical assistance they need. Thank you for your consideration and your commitment to respect the ability of youth to make responsible choices.

SPONSOR STATEMENT

HOUSE BILL 430

“AN ACT MAKIING AN APPROPRIATION FOR THE CONSTRUCTION OF THE PALMER SENIOR CENTER; AND PROVIDING FOR AN EFFECTIVE DATE.”

We are all aware the Mat-Su Borough is experiencing above average growth, but it may not be as commonly known that a subgroup of this population is growing even faster. According to the most recent Census data available, Alaska's senior population is both the fastest growing segment of Alaska's population and surprisingly also one of the fastest growing senior population in the nation. The number of Alaskans over age 60 is expected to triple from 53,000 (8.5% of Alaska's population) in the year 2000 to 165,000 (20% of Alaska's population) by 2025, less than 20 years away. More specifically, in the Mat-Su the senior population increased by 150% from 1990 to 1999 and is expected to double again before the year 2018. Palmer Senior Citizens Center (PSCC) currently serves 450 Mat-Su seniors every day.

The current facility has problems including defective electrical systems. Interestingly, the Executive Director's computer loses power when the photocopier is used. There are fifty parking spots and a fleet of 15 vans for 35 on-site employees and 100 seniors at meal times. Many employees of PSCC work off-site due to limited space availability at the center.

PSCC is a 501 (c)(3) non-profit organization, already owns the new site, and is only seeking funds for design and construction.

I urge your support and favorable action on this legislation.

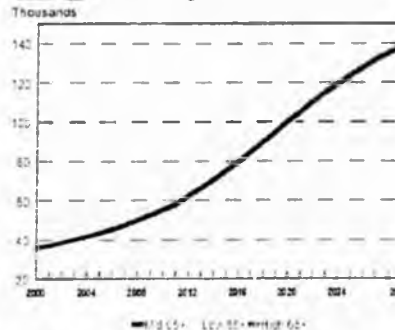

PROJECT NARRATIVE

ALASKA'S SENIOR POPULATION

According to the Alaska Department of Labor and Workforce Development and the 2000 U.S. Census, Alaska's senior population is not only the fastest growing segment of Alaska's population, but also one of the fastest growing senior populations in the nation. The Alaska State Demographer projects that the number of Alaskans age 65 and over will nearly triple over the next two decades, from 41,600 in the year 2005 to more than 119,000 by 2024.¹ This alarming trend is particularly evident in the Mat-Su Borough, which experienced 15.1% growth in its senior population between 2000 and 2002.² According to the State Demographer, "The impact of the rapidly increasing numbers of older residents may be greater than elsewhere, because Alaska ... has fewer existing resources to serve the elderly."³

ROLE OF SENIOR CENTERS

As the State of Alaska and the Matanuska-Susitna Borough struggle to keep pace with the growing needs of their respective senior populations, the role of non-profit senior organizations has become increasingly important. A 2005 update of the Mat-Su Agency Partnership's Community Needs Assessment addresses senior service needs in the Mat-Su Borough and identifies as a priority the "further development of senior centers as the access point for senior services and a nexus for resource referral and services."⁴

In 2005, Palmer Senior Citizens Center, Inc. (PSCC) proudly celebrated twenty-five years of service to the Mat-Su community. As the Borough's senior population swells, PSCC has consistently stepped up to address the emergent needs of seniors from all corners of the Mat-Su Borough. PSCC administers eleven critical programs to approximately 250 seniors each business day. PSCC's services are intended to help older Alaskans remain healthy, independent members of their communities. This philosophy improves the standard of living for senior citizens and results in substantial cost savings for the State of Alaska.

COST EFFECTIVENESS

By assisting seniors to remain independent, PSCC's services decrease the need for costly, premature institutionalization in assisted living facilities and nursing homes. In 2005, the average annual cost of assisted living care in Alaska was \$45,636.⁵ The average cost of nursing home care for a single Alaskan senior was more than \$200,000 per year in 2005, far and away the highest cost of care in the nation.⁶ The most frightening statistic, however, is rate at which costs for institutional care are rising: 5% per year for assisted living and 6% per year for nursing home care.⁷

The State of Alaska is in the process of repositioning individuals out of nursing homes, in favor of more cost-effective home and community-based services such as those offered by PSCC. The Public Consulting Group estimates that the transition of just ninety-nine such individuals between July 2002 and September 2005 has already resulted in a cost savings of roughly \$8,845,000.⁸

Service-oriented senior centers are a critical component of any plan to avoid the institutionalization of Alaskan seniors in nursing homes and assisted living facilities. For example, PSCC provides home and community-based services to approximately 140 individuals who would likely be institutionalized if our services were not available.⁹ The cost of nursing home care for those 140 individuals for just one year would exceed \$28,000,000.¹⁰ Remember to increase that figure by 6% each and every year.¹¹ Clearly, it is crucial to invest in Alaskan senior centers so that they remain capable of meeting the growing needs of our senior population.

Unfortunately, PSCC's existing facility has become woefully inadequate, as we no longer possess the floor space needed to keep pace with the increasing demand for senior services in the Mat-Su Borough. PSCC requires a modern facility with sufficient space to accommodate administrative and program offices, dining and meal facilities, vehicle and equipment maintenance operations, and senior activities. A brief description of PSCC's current facilities highlights their substantial limitations.

PSCC'S EXISTING FACILITIES

The Palmer Senior Citizens Center is located in a renovated church, which was originally constructed in 1956. PSCC spearheaded efforts to obtain the building for use as a senior citizens center, and, due to legal considerations, the facility was conveyed to the City of Palmer in 1981. To this day, PSCC continues to utilize the facility with approval from the City of Palmer. Although PSCC and the City of Palmer completed an addition to the building in 1986, the entire facility contains less than 10,000 square feet. Within this space, PSCC houses its dining hall, a commercial kitchen, food storage, administrative offices, transportation program offices, an information / referral office, a purchasing office, employment assistance offices, a gift shop, equipment storage, records storage, space for senior programs and activities, and much more. Simply put, PSCC has run out of room.

Due to the limitations of PSCC's current facility, many of our employees must work off-site, away from the senior center and PSCC's administrative offices. PSCC's Care Coordination and Living Well Care Coordination programs are housed at an off-site commercial facility, which PSCC currently rents at the rate of \$1,350.00 per month. This arrangement results in increased program costs in the form of rents, as well as additional administrative expenses. The physical gap between PSCC's administrative staff and its front-line service providers causes administrative inefficiencies that would be easily resolved if PSCC's various programs and administration were housed under a single roof.

Because of its age, PSCC's existing facility is plagued by mechanical, electrical, and structural defects that we must continuously remedy to make it safe and functional for staff and senior clients. For example, the electrical systems in PSCC's main facility recently deteriorated to the point that utilizing the photocopy machine in our administrative office would sap power from the Executive Director's adjacent office, causing his computer to shut down!

Parking is a growing concern at PSCC's main facility. Currently, the Palmer Senior Citizens Center has approximately fifty parking spaces to accommodate thirty-five on-site employees, up to one hundred seniors who may eat at our dining hall on any given day, and our current fleet of fifteen vans, which are an integral part of our extensive transportation program.

Enclosed with this Project Summary you will find a photographic tour of the Palmer Senior Citizens Center. Additionally, PSCC is pleased to offer live tours of our existing facility to any group or individual interested in observing first-hand its substantial limitations. PSCC is proud of its rich history of service to the community and its increasingly pivotal role in addressing the diverse needs of seniors in the Mat-Su Borough. However, the inadequacy of our outdated, overcrowded facilities has caught up with us. Because of the physical limitations and financial burdens associated with our current facilities, it has become virtually impossible for PSCC to assume new responsibilities or tackle additional challenges on behalf of the Borough's senior population. It is for this reason that PSCC proposes the development of a new senior citizens center within the City of Palmer.

PROJECT OVERVIEW

The proposed senior citizens center will consist of a single two-story building of approximately 20,500 square feet. The facility will be able to house all of PSCC's staff and programs, with the exception of our adult day services program. Conceptual floor plans are provided below on pages 10 and 11.

The ground floor of the proposed facility will contain approximately 14,200 square feet. Approximately 5,000 square feet on the ground floor will be dedicated to a new congregate meal facility, which will be sufficient in size to accommodate the growing need for senior nutrition services in the eastern half of the Mat-Su Borough's "core" area for years to come. The congregate meal facility will include a dining hall, commercial kitchen, freezer space, and storage for dry goods. Also included in the plans for the ground floor is a 3,400 square foot garage / maintenance facility, which will include space for equipment storage. The remaining 5,800 square feet on the first floor will be divided between reception, a transportation office, a gift shop, an exercise room, senior recreation areas, restroom facilities, a mechanical room, and storage.

An elevator and two sets of stairs will connect the ground floor to a smaller second floor consisting of approximately 6,300 square feet. The second floor will provide office space for PSCC's administration and program staff. In addition, the upper level will contain a modest conference room, records storage, and storage for office supplies.

PSCC proposes to utilize land it already owns as the site for the new facility. PSCC's undeveloped property is located within a burgeoning senior district in the City of Palmer. The Palmer Pioneer and Veterans' Home, PSCC's adult day services facility, Colony Estates Senior Housing, and Willow Pointe, a multi-unit residential facility with a large number of senior tenants, are all located within one block of the proposed site. Additional senior housing is located a short distance away on South Chugach Street. In addition, PSCC owns a significant amount of property adjacent to the proposed site and intends to develop the property into a residential community for seniors. Indeed, pre-development activities are underway for the first phase of that development, a 30-unit senior apartment building. The proposed senior center will be the very heart of PSCC's senior residential community.

The current estimated cost of PSCC's proposed facility is \$4,901,280. While this price tag reflects a substantial investment in Alaska's seniors, a quick cost comparison to a typical Alaskan elementary school is enlightening. The Matanuska-Susitna Borough will hold a special election on May 2, 2006, placing on the ballot a measure to spend up to \$39,700,000 on the design, construction, and renovation of local schools. Included in that cost are proposals for two new elementary schools at a cost of up to \$17,000,000 each. In contrast, PSCC's proposed facility, which would allow us to effectively serve more than 250 elderly individuals each day, is modest and cost-effective.

THE SPONSOR

Palmer Senior Citizens Center, Inc., a 501(c)(3) non-profit organization, was incorporated in Alaska in 1980. PSCC's primary mission is to promote honor, dignity, security, and independence for older Alaskans and to assist them in maintaining meaningful, quality lives. PSCC strives to provide Mat-Su seniors with the individual services they require to remain autonomous and avoid the astronomical costs associated with premature institutionalization. For the past quarter century, PSCC has provided critical services to seniors and disabled adults living in Palmer, Wasilla, Knik/Fairview, Meadow Lakes, Big Lake, Houston, Willow, Talkeetna, Trapper Creek, Lakes/Midtown, Gateway, Butte, Lazy Mountain, Knik River, Sutton, Chickaloon, Eureka, and areas in between. PSCC's programs and services include the following:

- Congregate Meals. PSCC's Congregate Meals program includes nutritious noon meals served each weekday at PSCC's congregate meal facility. During State of Alaska fiscal year 2005, PSCC served 25,421 congregate meals to 712 unduplicated clients.

- Home-Delivered Meals. Utilizing its own transportation fleet, PSCC delivered 29,567 nutritious meals to eligible homebound seniors and disabled adults during State fiscal year 2005.
- Transportation. PSCC's Transportation program provides rides for seniors and disabled adults. During State fiscal year 2005, PSCC provided approximately 22,147 individual rides totaling more than 217,200 miles. PSCC's Transportation program services a vast geographical area, covering approximately 2,500 square miles.
- Adult Day Services. PSCC's Adult Day Services program provides a safe, healthy environment for frail, elderly individuals and adults with Alzheimer's disease and related disorders who are at risk of being left unsupervised during the day. During State fiscal year 2005, 110 clients attended PSCC's Adult Day Services program for a total of 45,825 service hours.
- Care Coordination. PSCC's Care Coordination program identifies physically and emotionally frail seniors and disabled adults and helps those individuals maintain independent, healthy, and dignified lifestyles through outreach, education, referral, and advocacy services. During State fiscal year 2005, PSCC provided care coordination services to 338 individuals.
- Living Well Care Coordination. PSCC's Living Well Care Coordination program provides specialized outreach, education, and care coordination services for seniors and disabled adults who suffer from mental illness and/or substance abuse. The Living Well program also offers support for caregivers of individuals who suffer from Alzheimer's disease and related disorders. The Living Well program was initiated in February 2005. By the end of the State fiscal year on June 30, 2005, PSCC had provided Living Well care coordination services to approximately 40 individuals in the Mat-Su Borough.
- Information and Referral. PSCC's Information and Referral program provides seniors and disabled adults with accurate, comprehensive information about assistance programs, community services, and legal issues such as Social Security eligibility, rental assistance, energy assistance, Medicare, Medicaid, powers of attorney, advance directives, and the Permanent Fund Dividend. Each month, PSCC's Information and Referral program assists approximately 500 individuals.
- Employment Assistance. PSCC's Older Workers Specialist helps individuals 55 years of age and older develop employable skills and transition into regular employment by coordinating job training opportunities and providing assistance with resume writing and interview skills.
- Chore Services. PSCC's Chore Services program assists eligible seniors to maintain their homes in a clean, sanitary, and safe condition. During State fiscal year 2005, PSCC provided 22 eligible clients with approximately 4300 hours of chore services.
- Senior Housing. PSCC operates and manages *Colony Estates Senior Housing*, a 24-unit senior housing facility located in Palmer. PSCC's sister organization, Palmer Senior Citizens' Center Housing Corporation, is proceeding with plans to develop additional senior housing within the Matanuska-Susitna Borough.
- Senior Companion Program. PSCC participates in a senior companion program that matches volunteer seniors with isolated elderly individuals in need of social contact.

- Senior Activities. PSCC organizes and coordinates a variety of smaller programs and activities for seniors and disabled adults, including an annual health fair, exercise classes, community brunches, AARP defensive driving courses, income tax assistance, bingo, and much more.

PSCC is grateful for the opportunity to offer Mat-Su seniors a variety of critical services that allow them remain healthy, happy, and independent for a longer period of time. When constructed, the proposed senior citizens center will provide vastly improved facilities for senior clients and permit PSCC to pursue its mission with greater administrative efficiency.

PROGRESS TO DATE

As mentioned above, PSCC has purchased and secured a suitable site for the proposed facility, which we estimate is valued at \$150,000. PSCC is prepared to initiate formal development activities, but further progress is dependent upon the availability of funding for this vital community project.

COMMUNITY SUPPORT

PSCC has already collected more than sixty letters of support from members of the community, including key health and social service organizations and community leaders like Matanuska-Susitna Borough Mayor Tim Anderson, the United Way of Mat-Su, the Mat-Su Agency Partnership, Valley Residential Services, Wasilla Area Seniors, and the Older Person's Action Group. In addition, the current draft of the soon-to-be updated Comprehensive Plan for the City of Palmer specifically states, "The City of Palmer strongly supports ongoing private efforts to develop a new senior citizens facility in Palmer."

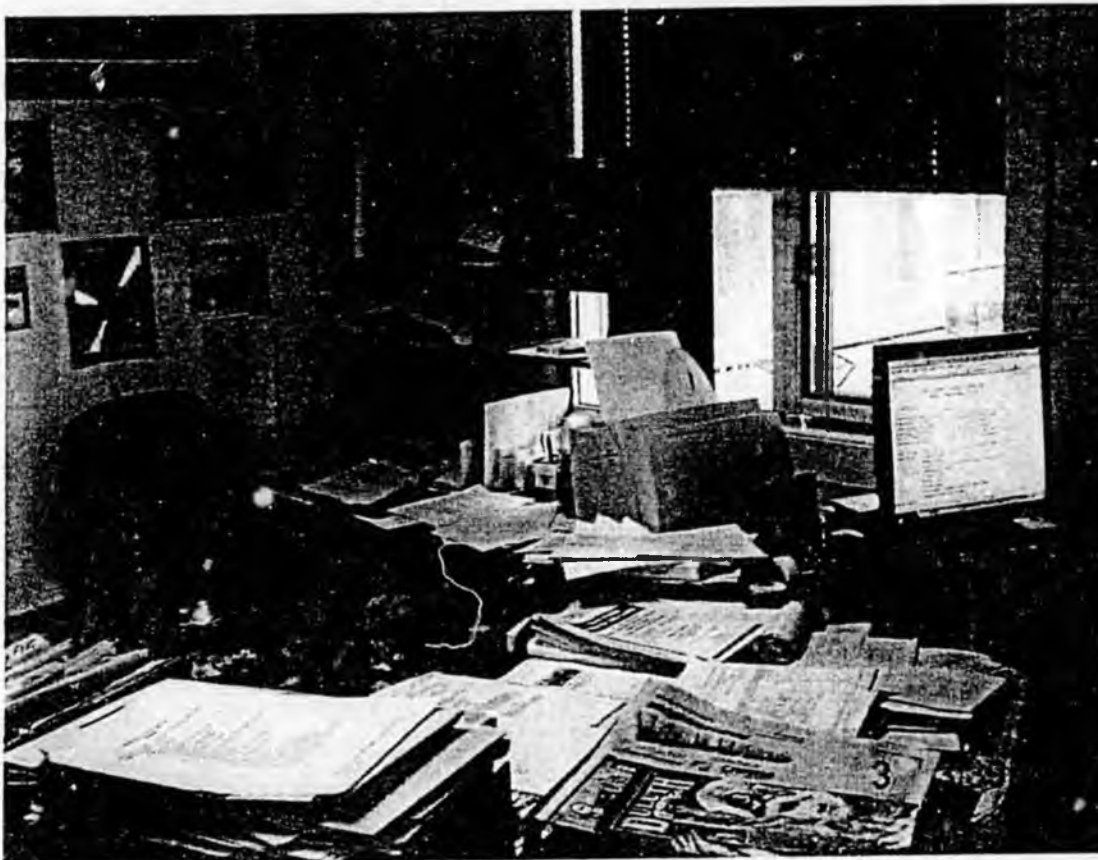

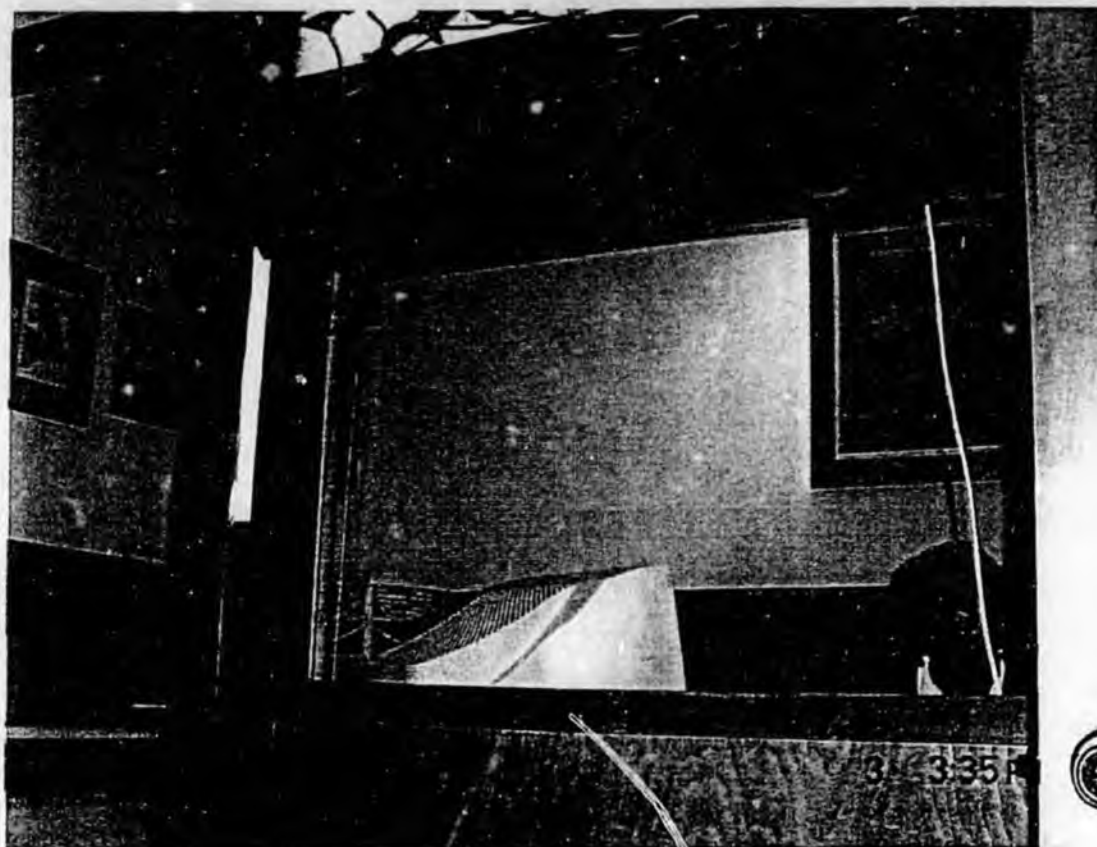

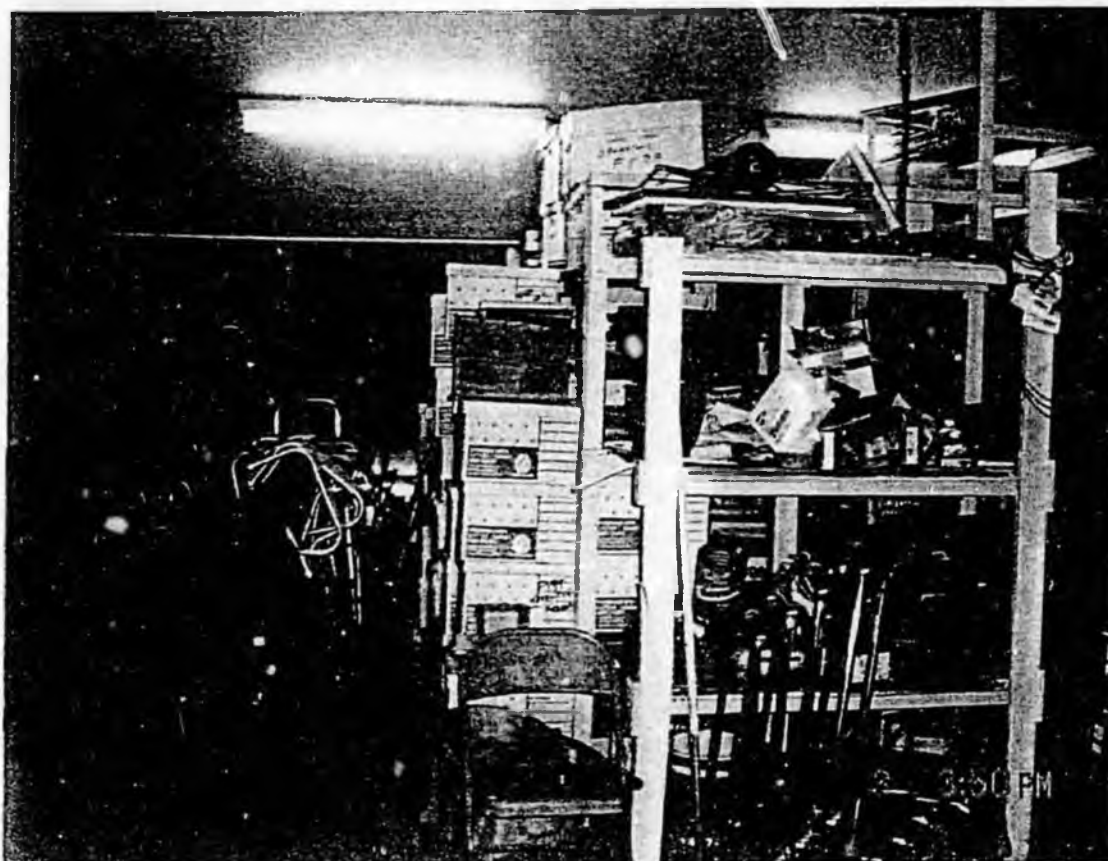

If senior organizations are to go on meeting the needs of elder Alaskans, our community must repair or replace outdated, overcrowded senior centers.



I understand that the Palmer Senior Center (PSC) is seeking support for a new facility to serve the Palmer community. I wanted to offer this letter of support for that endeavor and express my appreciation for the years of cooperative efforts our agencies have shared.

I have depended upon many services of the PSC in the 8 years I have lived and worked in the Mat-Su Valley. First, your Care Coordination program (currently located outside your main facility) has been a tremendous asset to those I serve who are near death but still need state assistance. Your Coordinators, under Christine's direction have never failed to respond in the urgent manner that so many of my patients and families need (given the severity of their condition). In the last year and a half, I have also been able to enter into an agreement with PSC (with Rachel's guidance) where I can obtain the Meals on Wheels lunches for those clients and families who would otherwise not qualify, and offset the cost of the meals using funds obtained during our fund-raising efforts.

Finally, I wanted to address the annual PSC Health Fair held in your current facility. As someone who generally attends each local health fair and staffs an information booth, I can say that the one at PSC is by far the largest and I have never been there that I didn't see a long line of seniors waiting for one service or another. These lines usually back up into the hallway and up the ramp. Several times, I have seen people double up to avoid having to wait outside for the line to move. Not only is this not healthy for the many elderly and frail seniors waiting for service, it is a barrier to those inside the building trying to access services (meals, etc.) that are unrelated to the health fair.

Needless to say, I am excited by the idea that the PSC is seeking to expand its' space and enlarge it's presence in the community. As everyone in the state surely knows, the Mat-Su Valley has been and will continue to be the fastest growing community in Alaska for years to come. 



I am writing this letter in support of the need of a larger, and more efficient Senior Center. Since I have been a constant volunteer for the past twenty-five years I believe I have a very good idea of some of the current problems with the existing structure.

During these past years I have volunteered for just about everything except driving the vans and their maintenance. But just about every other thing from planting flowers to watering the lawn over the weekends, helped in the kitchen and even cook the lunch a couple of times (long before home-delivered meals) washed windows, moped floors etc.

The plus for the current building is location, location and location since it is adjacent and across the street to two Senior Housing units as well as having the Day Care Center across the street. The large garage has several bays for the Vans plus a dry storage in part of the loft as well as emergency food supply for any disaster for the community. And there is a paved parking lot.

Now for the really current unhandy building---it has insufficient office arrangements in every nook and crevice that can be located. The basement is a great problem, having a walk-in cooler and freezer for food storage that has to be pushed up a long, long ramp to get to the kitchen.. There is inadequate storage for all supplies.

I would suggest that this current building be torn down, and rebuilt and if possible salvage the basement foundation, but rebuild on the same location.

Now to continue the services perhaps an arrangement with the School Central kitchen for the home delivered meals and have the Wasilla Center take care of all West of Four Corners and the noon meal might be served in one of the near-by churches....we started out in the Catholic Church before they remodeled and it was very unhandy---cooked up stairs and carried all food and dishes downstairs---dishwasher upstairs! But with lots of volunteers we made it!

I hope I live long enough to enjoy a new Senior Center in the same location.
