Constitutional Convention Article/5 January 23, 1956 CONSTITUTIONAL CONVENTION OF ALASKA REPORT OF THE COMMITTEE ON STYLE AND DRAFTING RESOLVED, that the following be agreed upon as part of the Alaska State Constitution: ARTICLE V SUFFRAGE AND ELECTIONS Qualified 1 Section 1. Every citizen of the United States who Voters 2 is at least nineteen years of age, qualified to vote under this article and not barred by any other provision 3 of law may vote in any state or local election. He 4 5 shall have been, immediately preceding the election, for 6 one year a resident of Alaska and for thirty days a resident of the election district in which he seeks to 7 8 vote. He shall be able to read or speak the English 9 language as prescribed by law, unless prevented by 10 physical disability. Section 2.
