

CHAPTER 53.

(H. B. No. 97.)

AN ACT to make appropriation for the Territory of Alaska for the fiscal year ending December 31, 1913, and for the fiscal year ending December 31, 1914, and for the quarter ending March 31, 1915.

Be it enacted by the Legislature of the Territory of Alaska:

That the following sums be, and they are hereby, appropriated, out of any money in the Treasury of the Territory of Alaska not otherwise appropriated, for the expenses of the Territory for the fiscal year ending December 31, 1913, and for the fiscal year ending December 31, 1914; and for the quarter ending March 31, 1915.

Territorial Treasurer. For salary of Territorial Treasurer for fiscal year ending December 31, 1913, two thousand dollars; for salary of Territorial Treasurer for fiscal year ending December 31, 1914, four thousand dollars; for salary of Territorial Treasurer for the quarter ending March 31, 1915, one thousand dollars; for contingent expenses in the office of Territorial Treasurer for the fiscal year ending December 31, 1913, seven hundred and fifty dollars; for contingent expenses in the office of Territorial Treasurer for the fiscal year ending December 31, 1914, twelve hundred and twenty-five dollars; for contingent expenses in the office of Territorial Treasurer for the quarter ending March 31, 1915, three hundred and six dollars and twenty-five cents; for miscellaneous expenses in the office of Territorial Treasurer to carry out the provisions of the Banking act, including stationery and office work in connection with said act, for the fiscal year ending December 31, 1914, seven hundred and fifty dollars; for miscellaneous expenses in the office of Territorial Treasurer to carry out the provisions of the Banking act, including stationery and office work in connection with said act, for the quarter ending March

31, 1915, one hundred and eighty-seven dollars and fifty cents.

Pioneers' Home. For the maintenance and furnishing of the Pioneers' Home located at Sitka, in accordance with the act creating said home, ten thousand dollars.

Mine Inspection. Salary of one mine inspector for fiscal year ending December 31, 1913, twelve hundred and fifty dollars; for a salary of one mine inspector for fiscal year ending December 31, 1914, twenty-five hundred dollars; for salary of one mine inspector for the quarter ending March 31, 1915, six hundred and twenty-five dollars; for traveling expenses of mine inspector for fiscal year ending December 31, 1913, twelve hundred and fifty dollars; for traveling expenses of mine inspector for fiscal year ending December 31, 1914, twenty-five hundred dollars; for traveling expenses of mine inspector for quarter ending March 31, 1915, six hundred and twenty-five dollars.

Indigent Home. For proposed indigent home in interior of Alaska, building said home, six thousand dollars; for maintenance of said home for fiscal year ending December 31, 1914, five thousand dollars.

Secretary of the Territory. For filing cabinets, index books, blank books, stationery, and territorial printing in the office of the Secretary of Alaska for fiscal year ending December 31, 1913, four hundred and twenty-five dollars; for filing cabinets, index books, blank books, stationery and territorial printing in the office of the Secretary of Alaska for fiscal year ending December 31, 1914, five hundred dollars; for necessary clerk hire in connection with territorial laws in the office of the Secretary of the Territory for the fiscal year ending December 31, 1913, fifteen hundred dollars; for necessary clerk hire in connection with territorial laws in the office of Secretary of the Territory for the fiscal year ending December 31, 1914, three thousand dollars; for necessary clerk hire in connection with territorial laws in the office

of Secretary of the Territory for the quarter ending March 31, 1915, seven hundred and fifty dollars.

Governor's Office. For clerk hire in the office of the Governor in connection with territorial laws for fiscal year ending December 31, 1913, fifteen hundred dollars; for clerk hire in the office of the Governor for work in connection with the territorial laws for fiscal year ending December 31, 1914, three thousand dollars; for clerk hire in the office of the Governor in connection with territorial laws for the quarter ending March 31, 1915, seven hundred and fifty dollars.

Dependent Children. For the care of dependent children not otherwise provided for in connection with the act creating juvenile courts and boards of childrens' guardians in the Territory of Alaska is hereby appropriated and made available to extend under the direction of the Governor for the period ending December 31, 1914, ten thousand dollars.

Board of Commissioners for the Promotion of Uniform Legislation in the United States. Alaska commissioners for promotion of uniform legislation in the United States, clerk hire, postage, office supplies, printing, incidental expenses for fiscal year ending December 31, 1913, five hundred dollars; for Alaska Commissioners for promotion of uniform legislation in the United States, clerk hire, postage, office supplies, printing, incidental expenses for fiscal year ending December 31, 1914, one thousand dollars; for Alaska commissioners for promotion of uniform legislation in the United States, clerk hire and postage, office supplies, printing and incidental expenses for quarter ending March 31, 1915, two hundred fifty dollars.

The Treasurer is authorized to pay out of the general fund any deficiency created by this legislature for printing of bills, stationery, journals and incidental expenses not to exceed one thousand dollars.
