SENATE CONCURRENT RESOLUTION NO. 3.

Relative to pro-rating of payment of mileage of members of Alaska Territorial Legislature

Whereas, as shown by the report of the joint committee on mileage, as now jointly adopted, that sufficient funds are not available with which to make payment, in full, to all of the members of the First Legislature of the Territory of Alaska, therefore,

Be it resolved, by the Senate of the Territory of Alaska the House concurring, that the Governor of Alaska, as disbursing officer of the fund set apart by the Congress of the United States, for the payment of mileage to the members of said Territorial Legislature, be, and he is, hereby requested to pro rate said mileage fund and make pro rata payment to the members of said Legislature in accordance with the report of said joint committee on mileage, so adopted as aforesaid.
