
Senate Concurrent Resolutions

SENATE CONCURRENT RESOLUTION NO. 1.

BE IT RESOLVED by the Senate and the House of Representatives concurring, that a joint session of the Senate and the House of said Legislature of the Territory of Alaska be held in the Hall of the House at two o'clock on the afternoon of Wednesday the 9th day of March A. D. 1921 for the purpose of receiving the message of the Governor of the Territory of Alaska.

Passed by the Senate, March 8, 1921.

Concurred in by the House, March 8, 1921.

SENATE CONCURRENT RESOLUTION NO. 2.

BE IT RESOLVED by the Senate, the House concurring, that no bill shall be introduced or received in the Senate, or the House of Representatives, of the Fifth Legislative Assembly of the Territory of Alaska, after the forty-fifth day of the session without the consent of two-thirds of the members to which the House is entitled in which the bill is introduced, and

That no bill shall be received by the Senate from the House, nor by the House from the Senate, after the fiftieth day of the session without the consent of two-thirds of the members to which such House is entitled, except general appropriation bills which shall not be received after the fifty-fifth day of the session.

Adopted by the Senate, March 15, 1921.

SENATE CONCURRENT RESOLUTION NO. 3.

WHEREAS, we consider it a duty devolving upon this Territorial Government to make proper and adequate provision for the care and comforts of those aged and infirm Pioneers who, in sturdy manhood and womanhood endured suffering, privations and great hardship, while blazing the trails and clear-

ing the way to make it easier for those who followed and now reap the fruits of their labor, and,

WHEREAS, it is necessary that we should be thoroughly informed as to existing conditions at the Pioneers' Home, to enable this Legislature to deal intelligently with the situation; now, therefore,

BE IT RESOLVED by the Senate, the House concurring, that a joint committee of this Legislature be appointed, consisting of two members from the Senate and three from the House to visit the Pioneers' Home at Sitka, at some later date, during this session of the Legislature and submit a report of existing conditions, together with such suggestions as present themselves for the betterment of the institution; to that end,

BE IT FURTHER RESOLVED, That a cable dispatch be forwarded to C. T. Gardner, Superintendent of Field Work of the Forestry Service, at Ketchikan, Alaska; requesting the Forestry Department to grant transportation to the said committee on one of their boats, of sufficient capacity for that purpose.

Passed by the Senate, March 21, 1921.

Concurred in by the House, March 23, 1921.

SENATE CONCURRENT RESOLUTION NO. 4.

BE IT RESOLVED by the Senate of the Territory of Alaska, the House of Representatives concurring, that the Secretary of the Territorial Banking Board be, and he is hereby, authorized and directed to cause 500 copies of the report of said Board to be printed and distributed to the members of the Legislature, public officers and banks of the Territory, and to others interested.

BE IT RESOLVED by the Senate, the House of Representatives concurring, that
