

CHAPTER 61.

AN ACT

[S. B. 41]

Authorizing the Territorial Board of Road Commissioners for Alaska to expend a sum not to exceed Ten Thousand Dollars (\$10,000), to be taken from the moneys appropriated for the construction, repair and maintenance of roads, trails and bridges and ferries and which may be allotted to the Second Division of Alaska at this session of the Territorial Legislature, for the purpose of locating, clearing, grading and preparing airplane landing fields in the Second Division of Alaska, and to pay to the city of Nome, Alaska, the sum of Twenty-five Hundred Dollars annually for the purpose of relieving said city of Nome of its obligation and agreement of December 22, 1917, with the War Department to pay annually the said sum of Twenty-five Hundred Dollars for the maintenance and improvement of the Nome harbor, and declaring an emergency.

Be it enacted by the Legislature of the Territory of Alaska:

Section 1. That the Territorial Board of Road Commissioners of Alaska is hereby authorized to expend out of the moneys appropriated at this session of the Territorial Legislature for the construction and maintenance of roads, trails, bridges and ferries in the Territory of Alaska and which may be allotted to the Second Judicial Division of Alaska, the sum of Ten Thousand Dollars, (\$10,000), or so much thereof as may be necessary, for the purpose of locating, clearing, grading and preparing airplane landing fields in the Second Division of Alaska at such places as the Board may select, and for the further purpose of paying to the said city of Nome the sum of Twenty-five Hundred Dollars annually to relieve said city of Nome of its obligation and agreement of date December 22, 1917, with the War Department to pay annually the sum of Twenty-five Hundred Dollars towards the maintenance and improvement of the harbor of said city of Nome.

Section 2. An emergency is hereby declared to exist and this Act shall be effective immediately upon its passage and approval.

CHAPTER 62.

AN ACT

[S. B. 42]

Authorizing the Territorial Board of Road Commissioners for Alaska to expend, in locating, clearing, grading, establishing, marking and preparing airplane landing fields and hydroplane anchorages and buoys at places to be selected by said Board in the Third Division of the Territory of Alaska, a sum not to exceed Ten Thousand Dollars (\$10,000.00) out of the moneys appropriated for construction and maintenance of roads, trails, bridges and ferries, and which may be allotted to said Third Division of the Territory of Alaska, and declaring an emergency.

Be it enacted by the Legislature of the Territory of Alaska:

Section 1. That the Territorial Board of Road Commissioners for Alaska is hereby authorized to expend out of the moneys appropriated at the present session of the Territorial Legislature, for the construction and maintenance of roads, trails, bridges and ferries, and which may be allotted to the Third Division of the Territory of Alaska, the sum of Ten Thousand Dollars (\$10,000.00), or so much thereof as may in the judgment of the Board be necessary or advisable, in the locating, clearing, grading, marking and establishment of airplane landing fields and hydroplane anchorages and buoys, or either, in said Third Division of the Territory of Alaska, at such places in said Division as said Board may select.
