

## Senate Joint Resolutions

### SENATE JOINT RESOLUTION NO. 1.

BE IT RESOLVED by the Legislature of the Territory of Alaska that, supplementing the invitation heretofore officially extended by the Governor, this body cordially invite the Governors of the forty-eight States to visit Alaska in connection with their next or subsequent annual conference; and that such invitation in the name of this Legislature be telegraphed to the Hon. E. Lee Trinkle, Governor of Virginia, Chairman of the Executive Committee of said Governors' Conference.

### SENATE JOINT RESOLUTION NO. 2.

BE IT RESOLVED by the Legislature of the Territory of Alaska that the Governor of said Territory by and hereby is authorized and directed to pay to Alexander Allan of Nome, Alaska, the sum of seventeen hundred fifty dollars (\$1750.00), for services rendered by said Alexander Allan during the year 1923, under the provisions of Chapter 47 of the Session Laws of Alaska, of the year 1923, in furnishing transportation service between Nome, Alaska, and St. Michael, Alaska, such payment to be made out of an appropriation therefor provided by Section 2 of Chapter 47 of the Session Laws of Alaska of the year 1923.

### SENATE JOINT RESOLUTION NO. 3.

BE IT RESOLVED BY THE SENATE AND HOUSE OF REPRESENTATIVES:

WHEREAS, at some canneries and salteries in the Territory, insanitary conditions prevail and the waters in the vicinity of many such establishments are often being polluted by offal deposited therein, which conditions are detrimental to the public in general and to the operators of the sanitary establishments in particular; and,

WHEREAS, housing facilities for and the comforts of the employees as well as the moral atmosphere at many such establishments is often deplorable; and

WHEREAS, the contract system for the accomplishment of much of the labor thereat entail many abuses; and

WHEREAS, the enactment of effective laws to remedy these evils without injuring the conscientious operators involves many intricate problems.

BE IT RESOLVED that the Attorney General is hereby instructed to place himself in communication and conference with the United States Bureau of Fisheries and the principal canneries and salteries and to acquaint himself thoroughly with the situations referred to with a view of obtaining information enabling him to draft laws for the purpose of enforcing equitable, reasonable and effective rules and regulations at canneries, salteries and similar establishments for the purpose of abating the evils complained of and submit his recommendations with such bills for laws as he may find adequate and equitable to the next session of the Legislature.

#### SENATE JOINT RESOLUTION NO. 4.

BE IT RESOLVED BY THE SENATE AND HOUSE OF REPRESENTATIVES:

WHEREAS, the Honorable Scott C. Bone, Governor of Alaska for the period of nearly four years last past, is about to leave the office of Governor; and,

WHEREAS, Governor Bone has filled that office with distinction to himself and with benefit to the Territory of Alaska and has endeared himself to the people of Alaska by his ability and industry as well as by the natural kindness and generosity of his spirit;

BE IT THEREFORE RESOLVED that the Alaska Territorial Legislature in Seventh regular session assembled, express its appreciation of the upright character and admirable qualities of Governor Bone and his sincere endeavor to do everything within his power for the welfare of the people of Alaska and the development of the Territory, and wish him Godspeed in the fields of his future life and work.
