

## CHAPTER 9.

## AN ACT

[H. B. 17]

Making appropriation for the payment of a deficiency in the appropriation for printing vital statistics forms and binding in permanent book form records of births, deaths, and marriages now on file; and declaring an emergency.

*Be it enacted by the Legislature of the Territory of Alaska:*

Section 1. That there be, and hereby is, appropriated from the General Fund of the Territory of Alaska, the sum of Two Hundred Thirty Five and 65/100 Dollars (\$235.65) for the payment of printing of vital statistics forms and binding in permanent book form records of births, deaths and marriages now on file, for the period ending March 31, 1927, for the payment of account justly due from the Territory under existing laws and payable from the above mentioned appropriation. Section 2. An emergency is hereby declared to exist and this Act shall be in full force and effect from and after its passage and approval.

## CHAPTER 10.

## AN ACT

[H. B. 14]

To repeal Chapter 30 of the Session Laws of 1919 and amendments thereto including Chapter 38 of the Session Laws of 1919, being an Act relating to the establishment of fish hatcheries and other purposes including the creating of a Territorial Fish Commission.

*Be it enacted by the Legislature of the Territory of Alaska:*

Section 1. That Chapter 30 of the Session Laws of Alaska for 1919, approved May 1, 1919, is hereby repealed.

Section 2. That Chapter 38 of the Session Laws of Alaska for 1919, approved May 3, 1919, is hereby repealed.

## CHAPTER 11.

### AN ACT

[H. B. 24]

To reimburse the City of Petersburg for expenses incurred during epidemic.

*Be it enacted by the Legislature of the Territory of Alaska:*

Section 1. That the sum of Three Thousand Two Hundred Seventy-Three Dollars and Forty-Seven Cents (\$3,273.47) is hereby appropriated to reimburse the City of Petersburg for expenses paid by the City during the smallpox epidemic of 1919; and the Treasurer of the Territory is hereby authorized to pay that sum to said City out of funds not otherwise appropriated.

## CHAPTER 12.

### AN ACT

[H. B. 50]

Making appropriation of moneys to provide allowances for certain aged residents of the Territory of Alaska, to be expended under and pursuant to the provisions of and for the benefit of the persons described in Chapter 46 of the Session Laws of Alaska of the year 1923; and declaring an emergency.

*Be it enacted by the Legislature of the Territory of Alaska:*

Section 1. There is hereby appropriated out of any moneys in the Treasury of the Territory of Alaska not otherwise appropriated, the sum of Five Thousand Dollars, (\$5,000.00), to be expended under and pursuant
