

Territory of Alaska not otherwise appropriated as payment to the contractor in full for additional labor and supplies furnished in the construction of the Kotzebue School House, the sum hereby appropriated being for the balance due.

Section 2. An emergency is hereby declared to exist Emergency. and this Act shall be in full force and effect from and after its passage and approval.

CHAPTER 15.

AN ACT

[H. B. 13]

To appropriate funds for payment of deficiencies in various appropriations heretofore made and declaring an emergency.

Be it enacted by the Legislature of the Territory of Alaska:

Section 1. The sum of \$750 is hereby appropriated Deficiency tax collection clerk. from the treasury of the Territory, or as much thereof as shall be necessary, for the purpose of paying the necessary expenditures of the office of Treasurer of the Territory for salaries and traveling expenses of tax collection clerks for the biennium ending March 31st, 1929, which appropriation is to be supplementary to the appropriation heretofore made for the same purposes.

Section 2. The sum of \$12,500.00 is hereby appropriated Deficiency bounty on wolves. out of the treasury of the Territory, or as much thereof as shall be necessary, for the payment of bounty on wolves for the biennium ending March 31st, 1929, which appropriation is to be supplementary to the appropriation heretofore made for that purpose.

Section 3. The sum of \$1,387.94 is hereby appropriated Deficiency support of schools. out of the treasury of the Territory, or as

much thereof as shall be necessary, for the purpose of support of schools in incorporated towns and incorporated school districts for the biennium which ended June 30th, 1927, which appropriation is supplementary to the appropriation heretofore made for that purpose and designed to supply the existing deficiency in said appropriation.

Emergency.

Section 4. An emergency is hereby declared to exist and this Act shall take effect immediately upon its passage and approval.

CHAPTER 16.

AN ACT

[S. B. 9]

Making appropriation for the reimbursement of Cecilia Carey for the expense incurred in the care and nurture of Claude Demoski, an orphan child, from September 15, 1921 to March 8, 1929, and declaring an emergency.

Be it enacted by the Legislature of the Territory of Alaska:

Appropriation
reimbursing
Cecilia Carey.

Section 1. The sum of One Hundred Twenty-five Dollars, (\$125.00) is hereby appropriated out of the Treasury of the Territory, not otherwise appropriated, to be paid to Cecilia Carey for reimbursement of the expense incurred in the care and nurture of Claude Demoski, an orphan child, from September 15, 1921 to March 8, 1929.

Emergency.

Section 2. An emergency is hereby declared to exist, and this Act shall take effect and be in force immediately upon its passage and approval.
