

CHAPTER 22.

AN ACT

[H. B. 40]

To appropriate One Thousand Six Hundred Ten Dollars (\$1610.00) for the city of Petersburg as reimbursement for cost of transporting pupils for the Public School from Scow Bay, and declaring an emergency.

Be it enacted by the Legislature of the Territory of Alaska:

Section 1. The sum of One Thousand Six Hundred Ten Dollars (\$1,610.00) is hereby appropriated for the city of Petersburg to reimburse the latter for actual expenses incurred in transporting pupils from Scow Bay to the Public School at Petersburg, and the Auditor of the Territory is directed to draw warrant against this appropriation in favor of the city of Petersburg.

Section 2. An emergency is hereby declared to exist and this Act shall take effect immediately upon its passage and approval.

CHAPTER 23.

AN ACT

[H. B. 48]

To appropriate the sum of Eighty-seven (\$87.00) Dollars to reimburse the Fairbanks Agency Company for transportation of certain pupils to the Public School at Fairbanks, and declaring an emergency.

Be it enacted by the Legislature of the Territory of Alaska:

Section 1. The sum of Eighty-seven (\$87.00) Dollars is hereby appropriated out of any monies in the Treasury of the Territory of Alaska, not otherwise appropriated, as payment to the Fairbanks Agency Company of Fairbanks, Alaska, for car hire and gasoline furnished

to transport pupils from the Farm Road to the Public School at Fairbanks, and the Auditor of the Territory is hereby directed to draw a warrant against this appropriation in favor of the said Fairbanks Agency Company.

Section 2. An emergency is hereby declared to exist and this Act shall take effect immediately upon its passage and approval.

CHAPTER 24.

AN ACT

[H. B. 52]

Providing for the investigation and study of the warble fly, nose fly and other pests and parasites preying upon the reindeer herds of Alaska, making an appropriation therefor and declaring an emergency.

Be it enacted by the Legislature of the Territory of Alaska:

Section 1. The sum of Six Thousand (\$6,000.00) Dollars is hereby appropriated from the Treasury of the Territory of Alaska, to be expended under direction of the Governor in cooperation with the Department of Agriculture, said sum to be used for the purpose of making a study and investigation of the warble fly, nose fly and other pests and parasites which prey upon the reindeer herds of Alaska, with a view to eradicating such pests and parasites.

Appropriation for investigation of reindeer pests.

Section 2. An emergency is hereby declared to exist and this Act shall take effect immediately on its passage and approval.
