

Appropriation.

Section 3. The sum of Five Hundred Dollars (\$500.00), or so much thereof as shall be necessary, is hereby appropriated out of the general fund of the Territory not otherwise appropriated to carry this Act into effect, which sum shall be paid on vouchers approved by the Governor.

## CHAPTER 70.

### AN ACT

[S. B. 20]

To authorize the Territorial Board of Road Commissioners of Alaska to construct an automobile and wagon road which will connect the City of Anchorage with the settlement of Eklutna in the Third Judicial Division, and to employ for that purpose Twenty-five Thousand Dollars (\$25,000.00) of the road funds apportioned to said Third Judicial Division under the provisions of Section 5 of Chapter 11 of the Laws of 1919, and to provide for co-operation between the Territorial Board of Road Commissioners and the Alaska Road Commission, and declaring an emergency.

*Be it enacted by the Legislature of the Territory of Alaska:*

Section 1. That the Territorial Board of Road Commissioners for the Territory of Alaska, is hereby authorized to construct an automobile and wagon road which will connect the City of Anchorage with the settlement of Eklutna in the Third Judicial Division of the Territory of Alaska; that in the performance of said work and in the construction of said road, the said Board shall expend not to exceed the sum of Twenty-five Thousand Dollars (\$25,000.00) during the ensuing biennium, but any portion of said sum may be expended upon said project irrespective of the total estimated cost thereof; that said Board shall not obligate the Territory of Alaska for the performance of said work in excess of the amounts which the Leg-

islature of Alaska may from time to time appropriate or allot for such purposes, that there is hereby allotted the sum of Twenty-five Thousand Dollars (\$25,000.00) to be used for carrying out the provisions of this Act, which amount shall be made available out of the monies which may be appropriated at the present session of the Legislature of Alaska and allotted to the Third Judicial Division of Alaska for the construction and maintenance of roads, trails, bridges and ferries; provided that the monies allotted under this Act shall be expended only after an investigation and a determination that the construction and maintenance of said road is feasible and advisable as a factor in the development or service of the territory affected.

Proviso.

Section 2. That as soon as possible after the passage and approval of this Act, said Territorial Board of Road Commissioners shall determine the most feasible route for the construction of said road either upon surveys and investigations heretofore made either by the Territorial Board of Road Commissioners or by the Federal Board of Road Commissioners for Alaska, commonly known as the Alaska Road Commission, or from further investigation or surveys made by either. That in the construction of such road the said Territorial Board of Road Commissioners shall have authority to enter into cooperative agreement with the said Alaska Road Commission, and in such event the Territorial funds available for such road may be expended by and under the direction of the latter.

Section 3. An emergency is hereby declared to exist and this Act shall be in full force and effect immediately upon its passage and approval.
