## CHAPTER 73.

### AN ACT

[H. B. 37]

To repeal Chapter 83 of the Session Laws of 1929, the same being an act to establish a teachers' pension fund, and giving the Act effect June 30, 1933.

*Be it enacted by the Legislature of the Territory of Alaska:*

Section 1. That Chapter 83 of the Session Laws of Alaska for 1929, be, and the same is hereby repealed. Repeal.

Section 2. This Act shall take effect on June 30, 1933.

## CHAPTER 74.

### AN ACT

[H. B. 5±]

Authorizing the Governor of Alaska to sell certain Territorial property and for other purposes, and declaring an emergency.

*Be it enacted by the Legislature of the Territory of Alaska:*

Section 1. That the Governor of Alaska is authorized and empowered to lease or sell, at a rental or Governor authorized to sell or lease property.

price to be agreed upon by a majority of the members of a Board to consist of the Governor of Alaska, the Territorial Treasurer and the Territorial Auditor, that certain property now belonging to the Territory of Alaska and described as follows:

**Description.**

Lot No. Four (4), in Block Eight (8) in the Town of Juneau, as per the official plat of said town, together with all buildings and improvements thereon.

**Governor authorized to execute deed.**

The Governor is authorized and empowered to make and execute in the name of the Territory of Alaska such deed, lease, or other instrument as may be necessary to carry out the purposes of this Act.

**Moneys covered into General Fund.**

Section 2. All money derived from the leasing or sale of the said property is to be covered into the General Fund.

**Emergency.**

Section 3. This Act to take effect immediately upon its passage and approval.

## CHAPTER 75.

### AN ACT

[H. B. 77]

To repeal Chapter 93, Session Laws of Alaska, 1923 as amended by Chapter 44, Session Laws of Alaska, 1925, creating a board of accountancy and defining its duties.

*Be it enacted by the Legislature of the Territory of Alaska:*

**Repeal.**

Section 1. That Chapter 93 of the Session Laws of Alaska, 1923, as amended by Chapter 44 of the Session Laws of Alaska, 1925, be, and the same is hereby repealed.
