### CHAPTER 3.

#### AN ACT

[H. B. 8]

To appropriate funds for payment of deficiencies in various appropriations heretofore made, and declaring an emergency.

*Be it enacted by the Legislature of the Territory of Alaska:*

Deficiency  
appropriation.

Section 1. The following sums of money are hereby appropriated from the treasury of the Territory, or as much thereof as shall in each case be necessary, for the purposes stated below, which appropriations are to be supplementary to the appropriations heretofore made for the same purposes:

For office of  
Commissioner  
of Education.

(a) Five Hundred Fifty Dollars (\$550.00) for contingent expenses of the office of the Commissioner of Education of Alaska for the biennium ending March 31, 1935.

For transpor-  
tation of  
pupils.

(b) One Thousand One Hundred Dollars (\$1,100.00) for the payment of transportation of pupils both within and without the boundaries of school districts; to be expended by the Commissioner of Education with the approval of the Board of Education for the biennium ending June 30, 1935.

For tuition.

(c) Eight Thousand Two Hundred Dollars (\$8,200.00) for the payment of tuition to incorporated towns and incorporated school districts for pupils residing outside the limits of such incorporated towns and dis-

tricts and attending either elementary or high schools therein for the biennium ending June 30, 1935.

Section 2. An emergency is hereby declared to exist and this Act shall be in full force and effect from and after its passage and approval. <sup>Emergency.</sup>

## CHAPTER 4.

### AN ACT

[H. B. 29]

Appropriating the sum of Two Thousand Dollars (\$2,000.00), or as much thereof as may be needed, to pay rent in temporary quarters for the Craig School and to purchase equipment and supplies for the same, and declaring an emergency.

*Be it enacted by the Legislature of the Territory of Alaska:*

Section 1. That the sum of Two Thousand Dollars (\$2,000.00) is hereby appropriated from the General Fund of the Territory of Alaska to be expended by the Commissioner of Education on vouchers drawn by him and approved by the Auditor for supplies and furniture for the Craig School and for rent for temporary quarters for the remainder of the school year 1934-1935. <sup>Appropriation for Craig school.</sup>

Section 2. An emergency is hereby declared to exist, and this Act shall take effect immediately after its passage and approval. <sup>Emergency.</sup>
