

CHAPTER 65.

AN ACT

[H. B. 128]

To appropriate the sum of Ten Thousand (\$10,000.00) Dollars for assistance and maintenance of a hospital at Seldovia, Alaska, for the benefit of the residents of Seldovia and vicinity.

Be it enacted by the Legislature of the Territory of Alaska:

Section 1. That the sum of Ten Thousand (\$10,000.00) Dollars is hereby appropriated out of the funds of the Territory of Alaska, to assist in the maintenance of a hospital in the village of Seldovia, Alaska, as hereinafter provided.

That Five Thousand (\$5,000.00) Dollars of this appropriation is to be made available March 1st, 1935, and a like sum of Five Thousand (\$5,000.00) Dollars to be made available on March 1st, 1936, and the total sum to cover the biennium ending March 1st, 1937. Provided, however, that the moneys herein appropriated are used only for the deficiencies incurred for the operation and maintenance of said hospital, payable quarterly upon vouchers approved by the Governor.

Section 2. That the appropriation herein made shall become available only in the event that an appropriation to construct the said hospital at Seldovia, Alaska, shall be obtained from the Federal Government as a grant for that purpose and said hospital is built and in operation, provided this appropriation shall not become effective or available until there shall be duly incorporated at Seldovia, a city of the second class or an independent school district.

Section 3. That the said hospital be operated and conducted by the Territorial Board of Health and that its management be in the hands of a local Board of Trustees, appointed by the Governor of Alaska, and residing at Seldovia, Alaska, and to be governed by

rules and regulations prescribed by the said Territorial Board of Health.

Payment—
When.

Section 4. That before any sums shall be paid under the provisions of this Act, the Board of Trustees of the said Hospital shall submit an itemized statement of its receipts and expenditures for the preceding year, which statement shall be certified to by the Chairman of the Board of Trustees.

CHAPTER 66.

AN ACT

[H. B. 87]

To appropriate the sum of Ten Thousand Dollars (\$10,000.00) for assistance and maintenance of a hospital at Kodiak, Alaska, for the benefit of the residents of Kodiak, and vicinity.

Be it enacted by the Legislature of the Territory of Alaska:

Section 1. That the sum of Ten Thousand Dollars (\$10,000.00) is hereby appropriated, out of the funds of the Territory of Alaska, to assist in the maintenance of a hospital in the village of Kodiak, Alaska, as hereinafter provided.

Appropriation.

That Five Thousand Dollars (\$5,000.00) of this appropriation is to be made available March 1, 1935, and a like sum of Five Thousand Dollars (\$5,000.00) to be available on March 1, 1936, and the total sum to cover the Biennium ending March 1, 1937.

Provision.

Provided, however, that the moneys herein appropriated are used only for the deficiencies incurred for the operation and maintenance of said hospital, payable quarterly upon vouchers approved by the Governor.
