

CHAPTER 9.

AN ACT

[H. B. 16]

To appropriate the sum of \$1125.00 to pay the salary of Oscar Olsen.

Be it enacted by the Legislature of the Territory of Alaska:

Whereas it appears that Oscar Olsen was duly elected Treasurer of the Territory at the general election held in September, 1934, pursuant to Chapter 37, Session Laws of 1933; and

Whereas under the provisions of said last named Chapter the term of office of the said Oscar Olsen as Treasurer commenced on the second day of January, 1935; and

Whereas the said Oscar Olsen did take his oath of office and qualify as Treasurer on said second day of January, 1935, and thereupon entered upon the performance of the duties of said office; and

Whereas Walstein G. Smith was duly elected Treasurer of this Territory pursuant to the provisions of Chapter 118, Session Laws of 1929; and whereas at the time of the election of the said Smith the term of office of the Treasurer commenced on the first day of April next succeeding his election and expired four years thereafter; and

Whereas the said Walstein G. Smith asserts to be entitled to perform the duties of the office of Treasurer and to receive the emoluments thereof until the first day of April, 1935, and is now performing the duties and drawing the emoluments thereof; and

Whereas it appears to be for the best interests of the Territory and as a matter of fairness that the said Oscar Olsen should be paid in view of the situation and the fact that he is and ever since the second day of

January, 1935, has performed needed services in the Office of the Treasurer;

Now therefore be it enacted by the Legislature of the Territory of Alaska:

Appropriating \$1,125.00 to pay Oscar Olson for services in office of Treasurer.

Section 1. That the sum of \$1125.00 be, and the same is hereby appropriated out of any funds in the Treasury to pay the compensation of Oscar Olsen, for services performed and to be performed by him in the office of the Treasurer commencing the second day of January, 1935, and expiring on the last day of March, 1935.

Emergency.

Section 2. An emergency is hereby declared to exist and this Act is to be in force and effect from and after its passage and approval.

CHAPTER 10.

AN ACT

[H. B. 28]

To amend Section 2383 Compiled Laws of Alaska, 1933, relating to general powers of councils in municipal corporations, by adding Sub-sections Sixteenth a and Sixteenth b thereto; and declaring an emergency.

Be it enacted by the Legislature of the Territory of Alaska:

Amending law with reference to municipal corporations.

Section 1. That Section 2383 Compiled Laws of Alaska, 1933, relating to general powers of Municipal Council in Incorporated Cities and Towns in Alaska be and the same is hereby amended by adding to Sub-section Sixteenth, Sub-sections Sixteenth a and Sixteenth b to read as follows:
