

CHAPTER 60.

AN ACT

[S. B. 39]

Relating to the duties of United States Marshals and Deputy United States Marshals in the Territory of Alaska, and declaring an emergency.

Be it enacted by the Legislature of the Territory of Alaska:

Duties of
United States
Marshals.

Section 1. It shall be the duty of the United States Marshals and Deputy United States Marshals in the Territory of Alaska to enforce all criminal laws enacted by the Legislature of the Territory of Alaska not inconsistent with the present duties of their respective offices.

Emergency.

Section 2. An emergency is hereby declared to exist and this Act shall be in full force and effect immediately upon its passage and approval.

CHAPTER 61.

AN ACT

[S. B. 54]

To amend Chapter LXXXVIII of the Compiled Laws of Alaska, 1933, by adding thereto Section 3639, relating to the time of settling bills of exceptions in actions at law.

Be it enacted by the Legislature of the Territory of Alaska:

Amended.

Section 1. That Chapter LXXXVIII of the Compiled Laws of Alaska, 1933, be amended by adding

thereto Section 3639, reading as follows: Section 3639. Parties to actions at law shall have the right, and they are hereby limited, to file their proposed bills of exceptions in the cause within three months of the entry of judgment therein. Provided, however, that the Court or Judge thereof may, for good cause shown, extend such time by order or orders entered prior to the expiration of said period or other periods of extension or extensions given by the Court or Judge thereof.

CHAPTER 62.

AN ACT

[S. B. 59]

To reimburse the Bethel Beach Home for the care of Julia May Sakagami and Rosa White, indigents, in the amount of Six Hundred and Fifty-five Dollars (\$655.00), and declaring an emergency.

Be it enacted by the Legislature of the Territory of Alaska:

Section 1. There is hereby appropriated out of the general funds in the Territorial Treasury, not otherwise appropriated, the sum of Six Hundred and Fifty-five Dollars (\$655.00) to reimburse the Bethel Beach Home, located near Juneau, for the care of Julia May Sakagami and Rosa White at Juneau, Alaska.

Section 2. The Treasurer of the Territory is hereby authorized to pay the amount hereinabove specified to the said Bethel Beach Home.

Section 3. An emergency is hereby declared to exist and this Act shall take effect immediately upon its passage and approval.
