

## CHAPTER 57.

## AN ACT

[H. B. 17]

To provide minimum salaries for school teachers.

*Be it enacted by the Legislature of the Territory of Alaska:*

Section 1. That the Board of Education and School Boards of incorporated cities in the Territory of Alaska shall pay teachers, regularly qualified in accordance with the Rules and Regulations of the Territorial Board of Education, and employed by them the following minimum salaries: for the First Division, Eighteen Hundred (\$1,800.00); Third Division, Nineteen Hundred Eighty (\$1,980.00) Dollars; Second and Fourth Divisions, Twenty-one Hundred (\$2,100.00) per annum; provided however, that nothing in this Act shall prohibit the employment of teachers at a higher rate than the minimum specified in this Act.

Section 2. A statement of the qualifications of each teacher employed by the Territory or by incorporated cities therein, shall be filed with the Commissioner of Education; such statement shall set forth the credits earned in College, Normal School, or University.

Section 3. The maximum number of teachers for which any municipality shall be entitled to reimbursement, shall be determined by the Board of Education.

Section 4. Refunds from the Territory to incorporated cities shall remain at the same rate as now prescribed by law, and be made in the same manner; provided, however no refunds shall be made on salaries of teachers, principals and superintendents in excess of the minimum established by this Act; and provided further, that no refunds shall be made to any incorporated city in Alaska on any salary paid less than the minimum established herein.

Effective date.

Section 5. This Act shall become effective at the beginning of the school year for 1939.

CHAPTER 58.

AN ACT

[H. B. 31]

To appropriate the sum of Twenty-five Thousand Dollars (\$25,000.00), to assist the City of Craig, Alaska, in the construction or alterations and addition to a School Building, and declaring an emergency.

*Be it enacted by the Legislature of the Territory of Alaska:*

Appropriation  
for Craig School  
Building.

Section 1. That the sum of Twenty-five Thousand Dollars (\$25,000.00), is hereby appropriated and made available and payable from road funds that shall be allotted to the First Division out of the appropriation provided by Chapter 19, Session Laws of Alaska, 1939, to assist the City of Craig, Alaska, in the construction or alterations and addition to a School Building.

How paid.

Section 2. The said sum shall be expended under the supervision of the Common Council of said City of Craig and shall be paid by the Territorial Treasurer upon vouchers approved by the Commissioner of Education.

Emergency.

Section 3. An emergency is hereby declared to exist and this Act shall be in full force and effect immediately upon its passage and approval.
