

CHAPTER 15.

AN ACT

[S. B. 28]

To cover into the General Fund the unexpended balance of \$175,000.00 appropriated by Chapter 53, Session Laws of Alaska, 1941.

Be it enacted by the Legislature of the Territory of Alaska:

Pioneers' Home
Addition.

Section 1. The unexpended balance of the sum of \$175,000.00 set aside for the construction of an addition to the Pioneers' Home at Sitka, Alaska, under the provisions of Chapter 53, Session Laws of Alaska, 1941, is hereby covered into the General Fund of the Territory.

CHAPTER 16.

AN ACT

[S. B. 25]

To appropriate the sum of One Thousand Eight Hundred Sixty Dollars (\$1,860.00) to pay the Town of Unalaska, Alaska, as a refund, to the said Town on Licenses issued within the municipality and declaring an emergency.

Be it enacted by the Legislature of the Territory of Alaska:

Appropriation
to refund Town
of Unalaska due
on licenses.

Section 1. That the sum of One Thousand Eight Hundred Sixty Dollars (\$1,860.00) is hereby appropriated for the purpose of paying the Town of Unalaska, Alaska, refunds due that town by virtue of licenses issued to sell intoxicating liquors within the said town as follows:

Section 2. That payment of said amount shall be made Payment.
upon vouchers approved by the Auditor of the Territory
of Alaska.

Section 3. An emergency is hereby declared and this Emergency.
Act shall take effect immediately upon its passage and
approval.

CHAPTER 17.

AN ACT

[S. B. 16]

To appropriate the sum of \$127.98 to reimburse J. A. Tesack for
overpayment of the inheritance tax due the Territory in the
estate of James Haughey, deceased, and declaring an emergency.

Be it enacted by the Legislature of the Territory of Alaska:

Section 1. That there is hereby appropriated out of Appropriation

the general fund in the Territorial Treasury not other-
wise appropriated the sum of \$127.98, to reimburse J. A.
Tesack for overpayment of the inheritance tax due to the
Territory in the estate of James Haughey deceased.

Section 2. The Treasurer of the Territory of Alaska How paid.
is hereby authorized to pay to the said J. A. Tesack the
said sum of \$127.98, herein appropriated.

Section 3. An emergency is hereby declared to exist Emergency.
