

CHAPTER 49.

AN ACT

[H. B. 91]

To amend Chapter 38, Session Laws of Alaska, 1943, relating to the imposition and collection of a School Tax and declaring an emergency.

Be it enacted by the Legislature of the Territory of Alaska:

School Tax
deposited in
school fund.

Section 1. That Section 12 of Chapter 38, Session Laws of Alaska, 1943, is hereby amended by adding thereto the following: "All sums collected under the provisions of this Act shall be deposited in the "School Fund" and same shall be used for school purposes only."

Repeal of con-
flicting Acts.

Section 2. That said Chapter 38 be further amended by adding thereto another section to be numbered "Section 15" to read as follows: "Section 15. REPEAL: Article 3 of Chapter 61, Compiled Laws of Alaska, 1933 and Section 1 of Chapter 72, Session Laws of Alaska, 1937 are hereby repealed."

Emergency.

Section 3. An emergency is hereby declared to exist and this Act shall be in full force and effect from and after the date of its passage and approval.

CHAPTER 50.

AN ACT

[H. B. 76]

To amend Sub-division (d) of Section 1, Chapter 86 of the Session Laws of Alaska, 1939; and declaring an emergency.

Be it enacted by the Legislature of the Territory of Alaska:

Amended.

Section 1. Sub-division (d) of Section 1, Chapter 86

of the Session Laws of Alaska, 1939, is hereby amended to read as follows:

“(d) The provisions of this Act shall include all forms of common carriers and particularly boats, airplanes, and buses, but shall not extend to payments made to common carriers operating scheduled trips at regular tariffs offered the general public; provided, however, that the provisions of this Act applicable to bus contracts for the transportation of pupils to and from public schools in the Territory, be suspended during the biennium ending June 30, 1945.”

Section 2. An emergency is hereby declared to exist and this Act shall take effect immediately upon its passage and approval.

CHAPTER 51.

AN ACT

[H. B. 89]

To amend Section 3 of Chapter 77, Session Laws of Alaska, 1937 as amended, relating to assay offices.

Be it enacted by the Legislature of the Territory of Alaska:

Section 1. That Section 3 of Chapter 77, Session Laws of Alaska, 1937 as amended, is hereby amended to read as follows:

“Section 3. The salary of each assayer shall not exceed Three Thousand Six Hundred Dollars (\$3,600.00) per annum and shall be paid upon vouchers approved by the Auditor.”
