

CHAPTER 29

AN ACT

[S. B. 28]

To waive the interest on the Twenty Thousand (\$20,000.00) Dollars of School Bonds of the Town of Wrangell, Alaska, held by the Territory of Alaska, for a period of ten (10) years.

Be it enacted by the Legislature of the Territory of Alaska:

Section 1. The interest on the School Bonds of the town of Wrangell, Alaska, held by the Territory of Alaska, in the amount of \$20,000.00 is hereby waived for a period of ten years. Interest waived.

CHAPTER 30

AN ACT

[S. B. 38]

Conveying certain lands to the City of Fairbanks, Alaska.

Be it enacted by the Legislature of the Territory of Alaska:

Section 1. The Territory of Alaska does hereby grant, bargain sell and convey unto the City of Fairbanks, a municipal corporation, all and singular the following described parcel of land, situated in the Fairbanks Precinct, Alaska, more definitely described as follows, to wit: Territory conveys to City of Fairbanks certain property.

Beginning at a point 1,125.3 feet North and 550 feet East of the S. W. corner of Section 10 T. 1 S. R. 1. W. Fairbanks Meridian; thence East along the South boundary of the Town of Fairbanks 650 feet; thence South 35 degrees 18 minutes E. 726 feet; thence N. 54 degrees 42 minutes E. 400 feet; thence N. 35 degrees 18 minutes

W. 424 feet; thence East along the South boundary of the Town of Fairbanks 420 feet; thence S. 00 degrees 28 minutes E. 1,750 feet; thence S. 89 degrees, 32 minutes W. 1,650 feet; thence N. 00 degrees 28 minutes W. 1,750 feet to the place of beginning and containing 60.5 acres.

Section 2. The Governor is hereby authorized to execute a deed for and on behalf of the Territory conveying said premises to said City.

CHAPTER 31

AN ACT

[S. B. 40]

To repeal Sections 585, 586, 587 and 588 of Article III, Compiled Laws of Alaska, 1933, relating to Bounty on Eagles.

Be it enacted by the Legislature of the Territory of Alaska:

Eagle bounty
repealed.

Section 1. That Sections 585, 586, 587 and 588 of Article III, Compiled Laws of Alaska, 1933, be and they are hereby repealed.
