

Be it enacted by the Legislature of the Territory of Alaska:

H. Kaser for office rent.

CHAPTER 63

AN ACT

[H. B. 54]

To appropriate the sum of Twenty-Seven Thousand Five Hundred Dollars (\$27,500.00) or so much thereof as shall be necessary, to build a twenty bed hospital at Petersburg, Alaska.

Be it enacted by the Legislature of the Territory of Alaska:

Appropriation—
Special construction
of hospital
at Petersburg.

Section 1. That the sum of Twenty-Seven Thousand Five Hundred Dollars (\$27,500.00) or so much thereof as shall be necessary, be, and the same hereby is appropriated out of monies in the Treasury not otherwise appropriated and made available to the Board of Administration for the construction of a twenty bed hospital at Petersburg, Alaska; the said sum to become available upon the city of Petersburg contributing a like amount toward the construction of the said hospital.

Fund to be

Section 2. The hospital shall be constructed under the supervision of the Highway Engineer when the town of Petersburg has made available \$27,500.00 previous to any assistance from the Territory.

Supervision of Highway Engineer.

CHAPTER 64

AN ACT

[H. B. 65]

To appropriate the sum of \$5,631,822.00 or as much thereof as shall be found necessary for the expenses of the Territory of Alaska for the biennium beginning April 1, 1945 and ending March 31, 1947, and for the school biennium beginning July 1, 1945 and ending June 30, 1947, and declaring an emergency.

Be it enacted by the Legislature of the Territory of Alaska:

Section 1. That the sum of \$5,631,822.00 or so much thereof as shall be found necessary is hereby appropriated out of any moneys in the Treasury of the Territory of Alaska not otherwise appropriated for the expenses of the Territory for the biennium commencing April 1, 1945, and ending March 31, 1947, and for the school biennium commencing July 1, 1945 and ending June 30, 1947, said sum to be apportioned according to the following schedules:
