

## CHAPTER 52

## AN ACT

[S. B. 24]

Authorizing the Territorial Board of Education to reimburse school boards for interest paid on money borrowed during the biennium July 1, 1947 to June 30, 1949; modifying Section 37-3-64 (d) ACLA 1949 to the extent necessary to pay such claim; making an appropriation and establishing an effective date.

*Be it enacted by the Legislature of the Territory of Alaska:*

Reimbursement  
of interest.

Section 1. The Territorial Board of Education is hereby authorized to reimburse school boards for interest paid on borrowed money during the biennium 1947-49, provided such interest payments by a school board were made on money borrowed to pay current operating expenses of the district because Territorial refunds as provided in Section 37-3-66 ACLA 1949 were delinquent.

Filing of claims.

Section 2. Any school board making a claim for such reimbursement shall file with the Commissioner of Education a notarized statement certifying the date such funds were borrowed, the amount of interest paid thereon, and that the funds borrowed were used for the sole purpose of defraying current operating expenses of the school because refunds due from the Territory were delinquent.

Section 3. Section 37-3-64 (d) ACLA 1949 is hereby modified only to the extent necessary for the payment of such claims.

Appropriation.

Section 4. The sum of \$10,000.00 or so much thereof as may be found necessary, is hereby appropriated out of the moneys in the Treasury not otherwise appropriated, for the purpose of paying interest claims authorized by Section 1.

Section 5. This Act shall become effective on July 1, 1949.

## CHAPTER 53

### AN ACT

[S. B. 23]

To change the name of "Unemployment Compensation Commission of Alaska" to "Employment Security Commission of Alaska"; amending Secs. 51-5-1 to 51-5-20 inclusive, ACLA 1949.

*Be it enacted by the Legislature of the Territory of Alaska:*

Section 1. The agency named the "Unemployment Compensation Commission of Alaska" as established in Sec. 51-5-10 ACLA 1949 is hereby given the new designation of "Employment Security Commission of Alaska" Change of agency name. and shall hereafter be known by said new name.

Section 2. Sec. 51-5-20 ACLA 1949 is hereby amended to read as follows:

Sec. 51-5-20 SHORT TITLE. This Act shall be known and may be cited as the Alaska Employment Security Law.

Section 3. Wherever the words "Unemployment Compensation Commission of Alaska" or "Commission" appear in Secs. 51-5-1 to 51-5-20 inclusive ACLA 1949, same shall be deemed to refer to the "Employment Security Commission of Alaska".
