## CHAPTER 52

### AN ACT

[H. B. 136]

To amend Section 61-16-4 ACLA 1949, relating to Final Accounts in the administration of decedents' estates.

*Be it enacted by the Legislature of the Territory of Alaska:*

Section 1. That Section 61-16-4 ACLA, 1949 is hereby amended by adding thereto the following:

No Final Order or Decree shall be made or entered in the administration of any estate in which the Territory is interested, either as a creditor or by way of escheat, unless it shall be made to appear to the satisfaction of the Court that certified copies of the Final Account and the notice of hearing thereon have been forwarded to the Territorial Treasurer. <sup>Notice to</sup> <sub>Treasurer.</sub>
