

such vehicle by the same or a different person. It shall not constitute a defense to a violation of this Act, nor shall it vitiate the intent required herein, that such person was under the influence of any drug or alcoholic beverage.

Vehicle defined.

(b) The word "vehicle" as used herein shall mean every device in, upon or by which any person or property is or may be transported or drawn upon a public highway, excepting devices moved by human power.

Persons excluded.

(c) The word "person" as used herein shall not include a United States Marshal or his deputy, a Highway Patrolman, or any other peace officer who drives, tows away, or otherwise takes a vehicle with authority under law to do so.

Section 2. Section 50-5-2 ACLA 1949 is amended to read as follows:

Larceny
prosecution.

Section 50-5-2 CONVICTION IN LARCENY PROSECUTION. Where, in a criminal prosecution for larceny of a vehicle, as the term "vehicle" as defined in Section 50-5-1 herein, the facts do not warrant a conviction of the defendant for larceny, he may, nevertheless, be convicted of a violation of the provisions of Section 50-5-1 as amended herein if the facts warrant a conviction for the violation thereof.

CHAPTER 104

AN ACT

[S. B. 33]

Pertaining to teachers' and superintendents salaries; amending Sections 37-6-1 and 37-6-2 ACLA 1949, as last amended by

Chapter 104, Session Laws of Alaska 1951; and establishing an effective date.

Be it enacted by the Legislature of the Territory of Alaska:

Section 1. Section 37-6-1 ACLA 1949, as last amended by Chapter 104, Session Laws of Alaska 1951, is hereby amended to read as follows:

Section 37-6-1. TEACHERS' SALARY RANGES BY DIVISIONS. The Territorial Board of Education and school boards of school districts in the Territory of Alaska shall pay teachers regularly qualified in accordance with the Rules and Regulations of the Territorial Board of Education and employed by them a salary within the following salary ranges: For the First Division, \$4,200.00 to \$5,600.00; Third Division, \$4,540.00 to \$5,940.00; Second and Fourth Divisions, \$4,800.00 to \$6,200.00.

Teachers' salary ranges.

Section 2. Section 37-6-2 ACLA 1949, as last amended by Chapter 104, Session Laws of Alaska 1951, is hereby amended to read as follow

Section 37-6-2. SUPERINTENDENTS' SALARY RANGES BY DIVISIONS. The Territorial Board of Education and school boards of school districts in the Terriotry of Alaska shall pay superintendents, regularly qualified in accordance with the Rules and Regulations of the Territorial Board and employed by them a salary within the following salary ranges: For the First Division, \$4,870.00 to \$6,975.00; Third Division, \$5,270.00 to \$7,375.00; Second and Fourth Divisions, \$5,570.00 to \$7,675.00.

Superintendents' salary ranges.

Section 3. This Act shall become effective July 1, 1953.
