

sum of \$10,000.00 from the General Revenue Fund and place the same to the credit of an account to be designated the "Alaska Wing, Civil Air Patrol Fund".

**Section 3. Appropriation of Funds.**

The sum of \$10,000.00 is hereby appropriated out of the "Alaska Wing, Civil Air Patrol Fund" for the biennium beginning July 1, 1955 and ending June 30, 1957, to be used by the Alaska Wing, Civil Air Patrol, for the acquisition, installation, conditioning and maintenance of the equipment and facilities thereof, and to be expended in search and rescue missions by the Alaska Wing, Civil Air Patrol; provided, however, no funds shall be expended thereby for the purchase of any new aircraft, uniforms or personal effects or for salaries of

members of the Alaska Wing, Civil Air Patrol.

**Section 4. Authorization of Expenditures.**

The Commanding Officer of the Alaska Wing, Civil Air Patrol, is hereby authorized and directed to issue vouchers covering all expenditures of said funds authorized and appropriated hereby, and the Territorial Auditor is directed to convert such vouchers into warrants and the Treasurer is directed to pay the same out of the funds herein provided for.

**Section 5. Emergency.**

An emergency is hereby declared to exist and this Act shall take effect immediately upon its passage and approval.

## CHAPTER 158

### AN ACT

**Relating to the support of guests of the Pioneers' Home; amending Section 51-2-13 ACLA 1949; and declaring an emergency.**

(H. B. 196)

**Be it Enacted by the Legislature of the Territory of Alaska:**

ACLA, 1949 be amended by adding thereto the following:

Section 1. That Section 51-2-13

Every person heretofore or

hereafter admitted to the Pioneers' Home, except persons admitted under Section 51-2-14 ACLA 1949, who receives income from any source whatsoever in excess of Fifteen (\$15.00) Dollars per month may be required, by the Board of Trustees to pay such excess to the Superintendent of said Home immediately upon receipt thereof in payment, or part payment, of the cost of his maintenance.

At the end of each month said Superintendent shall transmit all

such payments to the Territorial Treasurer together with the names of the persons making same and the amount paid by each. Provided, that the Board of Trustees is hereby authorized to pay the sum of \$5.00 per month to any resident without funds.

All moneys thus received shall be covered into the General Fund.

Section 2. An emergency is hereby declared to exist and this Act shall take effect immediately upon its passage and approval.

## CHAPTER 159

### AN ACT

**Relating to the construction program for the University of Alaska; and making an appropriation.**

(H. B. 197)

**Be it Enacted by the Legislature of the Territory of Alaska:**

Section 1. There is hereby appropriated to the University of Alaska the sum of \$1,300,000.00, or so much thereof as may be matched as hereinafter provided, out of any moneys in the General Fund not otherwise appropriated. The appropriation herein provided shall be

made available according to the following schedule: (a) \$650,000.00 to be made available on October 1, 1957; and (b) \$650,000.00 to be made available on October 1, 1958.

Section 2. The moneys appropriated shall be expended on construction of buildings and facilities on the campus of the University of Alaska; Provided however, that
