

LAWS OF ALASKA

CHAPTER 1

AN ACT

To appropriate the sum of \$137,100.00 for Legislative expenses; and declaring an emergency.

(H. B. 2)

Be it enacted by the Legislature of the Territory of Alaska:

Section 1. That the sum of \$137,100.00 or so much thereof as shall be found necessary is hereby appropriated out of any monies in the Treasury of the Territory of Alaska not otherwise appropriated for the payment of salaries to persons employed by the Senate and House of Representatives of the Territory of Alaska during the present session and for other such necessary legislative expenses, said sums to be apportioned according to the following schedules:

(1) For the salaries of the Chief Clerk of the House of Representatives and the Secretary of the Senate, \$26.00 per day for 71 days, which includes 11 days service in preparation of Journal; one Assistant Clerk of the House of Representatives, \$22.00 per day for 60 days; one Assistant Secretary of the Senate at \$22.00 per day for 60 days; the sum of.....\$6,332.00

(2) For the salaries of the Sergeant-At-Arms of the House of Representatives, \$18.00 per day for 60 days, and the Sergeant-At-Arms of the Senate, \$18.00 per day for 60 days; the sum of..... \$2,160.00

(3) For the salaries of the following employees of the Senate for

60 days; one Engrossing Clerk and one Enrolling Clerk at \$18 per day; one Bill Clerk and six Typists at \$17.00 per day; one Judiciary Clerk, one Finance Committee Clerk, two stenographers at \$19.00 per day; one mimeograph operator and two messengers at \$16.00 per day, and one doorkeeper and one watchman at \$15.00 per day; the sum of.....\$18,540.00

(4) For the salaries of the following employees of the House of Representatives, for 60 days, four stenographers at \$19.00 per day; one Enrolling Clerk and one Engrossing Clerk at \$18.00 per day; one mimeograph operator, one Bill Clerk, one Proof Reader and seven typists at \$17.00 per day; one Mail and File Clerk and two messengers at \$16.00 per day; one doorman and one watchman at \$15.00 per day; the sum of.....\$21,600.00

(5) For the salaries of the Chaplain of the House of Representatives, for 60 days at \$6.00 per day; and for the Chaplain of the Senate, 60 days at \$6.00 per day; the sum of \$720.00

(6) For the payment of additional services rendered by the President of the Senate and the Speaker of the House of Representatives of the Territory of Alaska during the regular session the sum of \$400.00 and

this money is to be equally divided.

(7) For the payment of compensation to such janitors and charwomen as are necessary to clean, care for and keep in proper order the rooms occupied by the Legislature at this session, the sum of \$3,000.00

(8) For the payment of necessary telephone service for use of the Legislature during the present session, the sum of \$88.00

(9) For the preparing of the Senate and House Journals, and the printing and binding of the Session Laws and advance sheets; and for printing and furnishing stationery and other printing for the use of the Legislature during the present session, the sum of \$20,000.00

(10) For the purchase of mimeograph paper, typewriting paper, stencils, carbons and such other material and supplies as may be necessary for the use of the Legislature during the present session, the sum of \$6,300.00

(11) For the payment of per diem in lieu of subsistence at the rate of \$20.00 per day for the members of the Legislature, 62 days each for regular members of both Houses and 71 days for the President of the

Senate and Speaker of the House, the sum of \$49,960.00

(12) For postage allowance of \$100.00 to be paid to each member of the House and Senate, as the estimated amount necessary to defray cost of mailing, telegraphing and otherwise communicating with constituents during this session, the sum of \$4,000.00

(13) For a Contingent Fund to be divided equally by House of Representatives and the Senate for use in defraying cost of extra mailing of a mass nature and hiring of additional help as needed or other contingencies and same to be drawn on by the authority of the Speaker of the House of Representatives or President of the Senate, respectively, the sum of \$4,000.00

Sec. 2. The monies hereby appropriated shall be paid by warrants drawn on the Treasurer of the Territory of Alaska upon vouchers approved by the President of the Senate and the Speaker of the House of Representatives.

Sec. 3. An emergency is hereby declared to exist, and this Act shall take effect immediately upon its passage and approval, or upon its becoming law without such approval.
