WHEREAS, if the above mentioned road were continued south along or near the shore of Cook Inlet a distance of about ten miles, through perfectly flat country, it would connect with the Kasilof River Road, and would open this area to homesteading, and would be of great value to the many resident fishermen who would use it in the summertime, allowing many of them to then live there the year around;

BE IT RESOLVED by the House of Representatives of the State of Alaska in

First Legislature, First Session Assembled, the Senate concurring, that construction of this connecting road be urged; and be it

FURTHER RESOLVED that copies of this resolution be properly engrossed and thereafter transmitted to the Honorable William A. Egan, Governor of Alaska; the Honorable Hugh J. Wade, Acting Governor of Alaska; the Honorable Frank Metcalf, Commissioner of Highways and Public Works; the State Board of Highways and Public Works; and the Bureau of Public Roads.

HOUSE CONCURRENT RESOLUTION NO. 17

Be it Resolved by the House of Representatives in the First Legislature, First Session Assembled, the Senate Concurring:

WHEREAS, the advent of statehood promises building development to an extent not heretofore existing in Alaska; and

WHEREAS, construction of public and private buildings should be accomplished in a manner conducive to the health and safety of the people of Alaska; and

WHEREAS, Alaska is without publicly approved building standards of statewide application for either private or public structures; and

WHEREAS, social waste occurs in terms of lives lost due to inadequately constructed buildings; and

WHEREAS, the people of Alaska must spend excessive amounts of money to maintain and insure buildings of substandard construction;

NOW THEREFORE, BE IT RESOLVED by the House of Representatives in the First Legislature, First Session Assembled, the Senate concurring, that the Legislative Council undertake a study directed toward adoption of a statewide building code, a statewide plumbing code, a statewide electrical code and a revised boiler code; and be it

FURTHER RESOLVED, that appropriations for use by the Legislative Council of Alaska's Legislature specifically contemplate funds for the study directed by this resolution.

Be it Resolved by the House of Representatives in the First Legislature, First Session Assembled, the Senate Concurring:

by the House of Representatives, the Senate concurring, that the time limit on transmission of bills set forth in Rule 64 be further changed to allow for the receipt of bills in the other house up to and including the last day of this First Session of the First State Legislature.
