

SENATE JOINT RESOLUTION NO. 18

Relating to vocational education.**Be It Resolved by the Legislature of the State of Alaska in Second Legislature, First Session Assembled:**

WHEREAS, the expansion of vocational education facilities is an aim jointly shared by the federal government and the State of Alaska; and

WHEREAS, the State of Alaska is undertaking the construction of additional facilities in the State thereby expressing its aim in concrete terms; and

WHEREAS, participation by the federal government in current and future State

programs would be of immeasurable benefit to the young citizens of Alaska;

BE IT RESOLVED by the Legislature of the State of Alaska in Second Legislature, First Session assembled, that the Bureau of Indian Affairs of the Department of the Interior is urged to participate in Alaska vocational school building programs which would benefit Alaskans who are one-quarter or more of Native blood and to extend financial aid to teachers commensurate with the number of Native youngsters of one-quarter or more of Native blood attending vocational schools.

SENATE JOINT RESOLUTION NO. 19

Relating to research in the shrimp fishing industry of Alaska.**Be It Resolved by the Legislature of the State of Alaska in Second Legislature, First Session Assembled:**

WHEREAS, the shrimp fishing industry is one of the most important resources in the waters of Southeastern Alaska; and

WHEREAS, within the last year there has been a 50% decrease in production; and

WHEREAS, it is essential to determine

the cause of the decline, and in addition to study the characteristics of the shrimp population within the appropriate habitat, in order to increase production;

BE IT RESOLVED by the Legislature of the State of Alaska in Second Legislature, First Session assembled, that the State Department of Fish and Game is urged to appoint one or more individuals to conduct a study of a permanent character into the shrimp fishing industry of Alaska.

SENATE JOINT RESOLUTION NO. 20

Relating to the Honorable Gordon Taylor, Highways Minister of the Province of Alberta.**Be It Resolved by the Legislature of the State of Alaska in Second Legislature, First Session Assembled:**

WHEREAS, the economic future of Alaska is, to a large extent, dependent upon sufficient transportation facilities to the rest of the United States and provinces of Canada; and

WHEREAS, the Alaska Highway represents the brightest hope for development of such sufficient transportation facility; and

WHEREAS, the Honorable Gordon Taylor, Highways Minister of the Province of Alberta has worked unceasingly for American and Canadian cooperation in paving the Alaska Highway; and

WHEREAS, the efforts of Gordon Taylor are largely responsible for present plans to pave the Alaska Highway from Fort Saint John, B. C. to the Alaska border; and

WHEREAS, Gordon Taylor has announced plans to continue his drive for cooperation in maintaining and improving the highway;
