

## SENATE RESOLUTION NO. 6

**Relating to the construction of steel piling breakwaters at the towns of Unalakleet, Shaktolik, Bethel, Fort Yukon, Seldovia, McGrath, and Kotzebue.**

**Be It Resolved by the Legislature of the State of Alaska in Second Legislature, First Session Assembled:**

WHEREAS, it is of paramount importance to the state and the nation to develop the economic potentialities of every Alaskan community; and

WHEREAS, the communities of Unalakleet, Shaktolik, Bethel, Fort Yukon, Seldovia, McGrath and Kotzebue desire to increase their contribution toward the economic betterment of the state; and

WHEREAS, the construction of breakwaters at Unalakleet, Shaktolik, Bethel,

Fort Yukon, Seldovia, McGrath and Kotzebue will serve the above purposes;

BE IT RESOLVED by the Legislature of the State of Alaska in Second Legislature, First Session assembled, that the Corps of Engineers, U. S. Army, be urged to plan and construct breakwaters at Unalakleet, Shaktolik, Bethel, Fort Yukon, Seldovia, McGrath and Kotzebue with all deliberate speed; and be it

FURTHER RESOLVED, that copies of this resolution be directed to the Honorable Elvis J. Stahr, Secretary of the Army; the Honorable E. L. Bartlett and the Honorable Ernest Gruening, U. S. Senators from Alaska; and the Honorable Ralph J. Rivers, U. S. Representative in Congress from Alaska.

## SENATE RESOLUTION NO. 8

**Relating to access roads to the water supply sources of Barrow and Kotzebue.**

**Be It Resolved by the Senate in the Second Legislature, First Session Assembled:**

WHEREAS, the state now has a program for the construction of access roads to help in the development of natural resources; and

WHEREAS, access to an abundant supply of fresh water is essential to the development of the human and other resources

of a community; and

WHEREAS, access to the water sources used by the communities of Barrow and Kotzebue is inadequate;

BE IT RESOLVED by the Senate in the Second Legislature, First Session assembled, that the Commissioner of Public Works is directed to construct during 1961 pioneer access roads from Barrow and Kotzebue to the site of their fresh water supplies.

Passed by the Senate February 21, 1961.

## SENATE RESOLUTION NO. 9

**Relating to the construction and maintenance of a recreation area in the vicinity of Salmon Lake, Nome, Alaska and Klawock Lake, Klawock, Alaska.**

**Be It Resolved by the Senate in Second Legislature, First Session Assembled:**

WHEREAS, the State of Alaska constructs and maintains recreation areas for the benefit of residents and tourists; and

WHEREAS, the continued development of Alaska's abundant scenic areas is of paramount importance for the expansion of the tourist and recreation industries; and

WHEREAS, a recreation area in the vicinity of Salmon Lake near Nome, Alaska and Klawock Lake near Klawock, Alaska would materially and aesthetically benefit both the residents of Alaska and the visitors to Alaska;

BE IT RESOLVED by the Senate in Second Legislature, First Session assembled, that the Governor is respectfully urged to direct the Commissioner of the Department of Natural Resources to take appropriate action to construct and maintain a recreation area in the vicinity of Salmon Lake and Klawock Lake.
