

Tatitlek of the small anchorage it once had for fishing boats and other vessels thus endangering the general economy of the village; and

WHEREAS the problem has been compounded by the influx of people from the destroyed village of Chenega who also need a safe anchorage for their boats; and

WHEREAS the dredging of a small harbor and the construction of a supporting breakwater would enable Tatitlek to safely house its regular fleet and meet the additional demands of marine traffic in the summer months, thus stabilizing the area economy and making possible future con-

nection with the state ferry system;

BE IT RESOLVED that the Corps of Engineers, U.S. Army, is requested to survey and make provision for the harbor and breakwater needs of Tatitlek; and be it

SENATE JOINT RESOLUTION NO. 65

Relating to the naming of a mountain in Alaska in memory of John Fitzgerald Kennedy.

Be It Resolved by the Legislature of the State of Alaska:

WHEREAS it would be appropriate for this state to establish a lasting tribute to the memory of John Fitzgerald Kennedy, 35th President of the United States, in order that future generations may be reminded of his selfless service to his country, his fine qualities as a man, and his talents as a leader of men; and

WHEREAS the naming of a towering peak in Alaska will serve as a timeless tribute by Alaskans and other Americans to this man whose loss to the world is still so keenly mourned;

BE IT RESOLVED that the Legislature requests the State Geographic Board to select and name a mountain in Alaska

appropriate in grandeur to honor the memory of John Fitzgerald Kennedy and to petition the United States Geographic Board for official designation of the mountain so named; and be it

SENATE JOINT RESOLUTION NO. 66

Relating to a highway connection between North America and Asia at Bering Straits.

Be It Resolved by the Legislature of the State of Alaska:

WHEREAS long - range international agreements and cooperation tend to tie nations together; and

WHEREAS joint projects and common interests of nations are a deterrent to destructive wars; and

WHEREAS an international highway from the southern tip of South America to the Bering Sea will soon be a reality; and

WHEREAS Asia and Europe are already

linked together with a complex highway system; and

WHEREAS the narrow Bering Straits are the only obstacle to prevent the tying together of the American and Eurasian continents by road;

BE IT RESOLVED that the United States government contact the government of the U.S.S.R. to explore their interest in constructing such a tunnel; and be it

FURTHER RESOLVED that the U.S. Department of Commerce be requested to cause a feasibility study to be made concerning the construction of an inter-continental highway to the Bering Sea

and a tunnel under the Bering Straits; and be it

FURTHER RESOLVED that this resolution be sent to the Honorable Lyndon B. Johnson, President of the United States; the Honorable Dean Rusk, Secretary of State; the Honorable John T. Connor, Secretary of Commerce; the Honorable Warren G. Magnuson, Chairman, Senate Commerce Committee; the Honorable Oren Harris, Chairman, House Interstate and Foreign Commerce Committee; and the Honorable E. L. Bartlett and the Honorable Ernest Gruening, U.S. Senators, and the Honorable Ralph J. Rivers, U.S. Representative, members of the Alaska delegation in Congress.

SENATE JOINT RESOLUTION NO. 67

Relating to the jurisdiction over Naval Petroleum Reserve No. 4.

Be It Resolved by the Legislature of the State of Alaska:

WHEREAS our nation is consuming petroleum products at a rate which far exceeds the discovery of new sources within our national boundaries; and

WHEREAS the oil and gas industry is currently engaged in an active exploration program all along the arctic slope of North America; and

WHEREAS there is presently established Naval Petroleum Reserve No. 4 containing 23 million acres which is not open to exploration and development by private enterprise; and

WHEREAS private enterprise is ready, willing and able to undertake the development of new petroleum reserves in the national interest;

BE IT RESOLVED that Naval Petroleum Reserve No. 4 as established by Executive Order No. 3797-A dated February 27, 1923, as amended by Public Land Order 289 dated July 20, 1945, be abolished and terminated; and be it

FURTHER RESOLVED that the lands encompassed in Petroleum Reserve No. 4 be restored to the public domain and that deposits of oil and gas underlying these be made subject to disposition by the Secretary of the Interior in the manner provided for by Act of Congress (41 Stat 437), as amended, or wholly by bid if so authorized by the Congress; provided that nothing shall affect the validity of any existing lease, license, permit, transfer or agreement, including the authority of the Secretary of the Navy under Public Law 87-599 (76 Stat 401) to develop the South Barrow gas field, and under Public Law 88-389 (78 Stat 340) to produce and sell crude oil from the Umiat field; and be it

SENATE JOINT RESOLUTION NO. 68

Protesting the decision of the Civil Aeronautics Board regarding air service between Alaska and Seattle.

Be It Resolved by the Legislature of the State of Alaska:

WHEREAS the Civil Aeronautics Board
