## AN ACT

Relating to compensation for state officers and employees; and providing for an effective date.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

\* Section 1. AS 39.20.030 is amended to read:

Sec. 39.20.030. SALARY OF SECRETARY OF STATE. The monthly salary of the secretary of state is 10 per cent above the highest pay step in range 28 of Salary Schedule I, as set out in ch. 27 of this title.

\* Sec. 2. AS 39.20.080 is repealed and re-enacted to read:

Sec. 39.20.080. SALARIES OF DEPARTMENT HEADS. The head of each principal executive department of the state is entitled upon his appointment and confirmation to a monthly salary of five per cent above the highest pay step in range 28 of Salary Schedule I, as set out in ch. 27 of this title.

\* Sec. 3. AS 39.27.010 is repealed and re-enacted to read:
