**MEMORANDUM**

June 11, 1971

TO: Users of the 1971 Session Laws of Alaska  
FROM: The Revisor of Statutes

Under the authority of AS 01.05.031, the revisor of statutes has renumbered certain Alaska Statutes provisions appearing in the 1971 session laws, as indicated below, to make the material more closely conform to the arrangement of the Alaska Statutes. The new numbers, which will appear in the 1971 supplement to the Alaska Statutes, are the ones to use in citing the material involved.
