## AN ACT

Relating to the regulation of nursing home administrators, nursing homes, and hospitals with skilled nursing beds or intermediate care beds; and providing for an effective date.

19 (4) intentionally or negligently engaged in or permitted the  
20 performance of patient care by persons under his supervision which does  
21 not conform to minimum professional standards regardless of whether  
22 actual injury to the patient occurred;

23 (5) failed to comply with this chapter, with a regulation  
24 adopted under this chapter, or with an order of the board;

25 (6) continued to practice after becoming unfit due to

26 (A) professional incompetence;

27 (B) addiction or severe dependency on alcohol or other  
28 drugs which impairs his ability to practice safely;

29 (C) physical or mental disability;

2 (8) practiced as a nursing home administrator or used a  
3 designation tending to imply that he is a nursing home administrator

7 Sec. 08.70.160. DISCIPLINARY SANCTIONS. (a) When it finds that a  
8 licensee is guilty of an offense under AS 08.70.155, the board may  
9 impose the following sanctions singly or in combination:

- 10 (1) permanently revoke a license to practice;  
11 (2) suspend a license for a determinate period of time;  
12 (3) censure a licensee;  
13 (4) issue a letter of reprimand;  
14 (5) place a licensee on probationary status and require him

15 to

16 (A) report regularly to the board upon matters involving  
17 the basis of probation;

18 (B) limit practice to those areas prescribed;

19 (C) continue professional education until a satisfactory  
20 degree of skill has been attained in those areas determined by the  
21 board to need improvement;

22 (6) impose limitations or conditions on the practice of a  
23 licensee.

24 (b) The board may withdraw probationary status if it finds that  
25 the deficiencies which required the sanction have been remedied.

26 (c) The board may summarily suspend a license before final hearing  
27 or during the appeals process if the board finds that the licensee poses  
28 a clear and immediate danger to the public health and safety if he  
29 continues to practice. A person whose license is suspended under this

1 section shall be entitled to a hearing by the board no later than seven  
2 days after the effective date of the order. The person may appeal the  
3 suspension after a hearing to a court of competent jurisdiction.

4 (d) The board may reinstate a license which has been suspended or  
5 revoked if the board finds after a hearing that the applicant is able to  
6 practice with skill and safety.

7 (e) The board shall seek consistency in the application of dis-  
8 ciplinary sanctions, and significant departure from prior decisions  
9 involving similar situations shall be explained in findings of fact or  
10 orders.
