BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

* Section 1. AS 08.62.020 is amended to read:

Sec. 08.62.020. APPOINTMENT AND TERM OF OFFICE. The governor shall appoint the pilot and agent or manager members of the board, subject to confirmation by a majority of the members of the legislature in joint session, for terms of four years, or until their successors are appointed. The first members shall be initially appointed for one, two, three and four year terms. No person, with the exception of the commissioner or his designee, may be appointed to the board for more than two consecutive terms.

* Sec. 2. AS 08.62.040(a)(3) is amended to read:

(3) keep a register of licensed pilots, and [VESSELS, OPERATORS,] agents [, AND MANAGERS];

* Sec. 3. AS 08.62.040(a)(4) is repealed and re-enacted to read:

(4) adopt regulations under the Administrative Procedure Act (AS 44.62) establishing standards by which pilotage fees may be established, and pay for audits whenever an audit is necessary to collect information needed to apply the standards in the regulations;
