BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

Making, amending, adjusting, repealing and reenacting,
and extending appropriations; and providing for an effective date."

* Section 1. The sum of \$64,500 is appropriated from the general fund to the Department of Labor for the workers' compensation program.

* Sec. 2. The sum of \$248,000 is appropriated from the general fund to the Department of Labor, division of employment security, to replace a reduction in federal funds for additional equipment and lease costs during transition to the new computer.

* Sec. 3. The sum of \$237,000 is appropriated from the general fund to the Department of Labor for the unemployment insurance system redesign capital project.

* Sec. 4. The sum of \$228,900 is appropriated from the general fund to the University of Alaska, Fairbanks, to pay sewage disposal costs to the College Utilities Corporation.

* Sec. 5. The sum of \$175,200 is appropriated from the general fund to the University of Alaska, community college statewide administration, for additional costs of the Alaska Community College Federation of Teachers contract for the fiscal year ending June 30, 1981.

* Sec. 6. The sum of \$384,000 is appropriated from the general fund to the University of Alaska, Fairbanks, to pay the costs of correcting deficiencies in structures at the agricultural experiment station research farm in Fairbanks.

20 in the Bristol Bay area.

21 * Sec. 12. The sum of \$600,000 is appropriated from the general fund to

23 future obligations to the employees and reimbursement of employees and
24 carriers during the fiscal year ending June 30, 1981.
