AN ACT

Making a special appropriation to the Department of Administration for a cost analysis of alternative designs for the state health communications network; amending and transferring appropriations for assistance payments and general relief medical and hospital payments; and providing for an effective date.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

AN ACT

* Section 1. The sum of \$130,000 is appropriated from the general fund to the Department of Administration for preparation of a cost analysis of alternative telecommunications designs for improvements to the statewide health communications network.
