



SUBJECT: Sections Renumbered
TO: Users of the 1985 Session Laws of Alaska

Under the authority of AS 01.05.031, the revisor of statutes has renumbered certain Alaska Statutes provisions appearing in the 1985 Session Laws to conform to the arrangement of the Alaska Statutes and to maintain a logical organization of the statutes. The numbering found in SLA chapters and the number that will appear in the Fall 1985 supplements to the Alaska Statutes are shown below.
