AN ACT

Relating to the governor's committee on employment of the handicapped; and relating to Alaska Employ the Handicapped Week.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

ARTICLE 2. GOVERNOR'S COMMITTEE ON EMPLOYMENT
OF PEOPLE WITH DISABILITIES [HANDICAPPED].

Sec. 23.15.220. PURPOSE. The purpose of AS 23.15.220 - 23.15.-320 is to create a governor's committee on employment of people with disabilities [THE HANDICAPPED] for Alaska to carry on a continuing program to promote the employment of people of the state with disabilities [THE HANDICAPPED CITIZENS OF THE STATE] by creating statewide interest in the rehabilitation and employment of people with disabilities [THE HANDICAPPED], and by obtaining and maintaining cooperation with public and private groups and individuals in this field.

Sec. 23.15.240. APPOINTMENT AND TERM OF CHAIR [CHAIRMAN]. The governor shall appoint a chair [CHAIRMAN] of the committee who serves as chair [CHAIRMAN] for one year or until a successor is appointed.
