AN ACT

Relating to controlled livestock districts.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

Relating to controlled livestock districts.

* Section 1. AS 03.35.010 is amended to read:

Sec. 03.35.010. ESTABLISHMENT [CREATION] AND RESTRICTION IN USE OF CONTROLLED LIVESTOCK DISTRICTS. (a) A district judge may [CREATE AND] establish a controlled livestock district within a municipality [CITY OR ORGANIZED BOROUGH,] or in other settled areas of the state, as provided in this chapter, to consist of [ONE OR MORE TOWNSHIPS OR PORTIONS THEREOF OR OF] a contiguous area of not less than 1,280 acres.

(b) The owner and the person having custody and control of a domestic animal kept within a controlled livestock district may not with criminal negligence permit the [IT IS UNLAWFUL FOR ANY] domestic animal to graze or run at large [WITHIN A CONTROLLED LIVESTOCK DISTRICT UNLESS THE DOMESTIC ANIMAL IS HERDED ON OPEN PUBLIC DOMAIN AND TENDED BY A PERSON AND PREVENTED FROM GRAZING UPON PRIVATE ROADS OR HIGHWAYS AND PRIVATELY OWNED LAND].

* Sec. 2. AS 03.35.010 is amended by adding a new subsection to read:

(c) Violation of (b) of this section is a class B misdemeanor.

* Sec. 3. AS 03.35.020(a) is amended to read:

(a) A controlled livestock district may be established [CREATED] upon petition of not less than 60 percent of the resident owners and lessees of the [CULTIVATED] land within the area to be included in the district who own or lease 30 percent of the land described in the

1 petition. The petition must [SHALL] contain a statement of its purpose,
2 [SHALL] define the boundaries of the area to be included within
3 the district, [SHALL] be signed by the required [REQUISITE 60 PERCENT
4 OF THE] resident owners and lessees within the area described, and
5 [SHALL] be filed with the district judge for the district within which
6 the land is situated.

7 * Sec. 4. AS 03.35.020(c) is amended to read:

8 (c) A portion [PORTIONS] of a controlled livestock district may
9 be eliminated or a [AN ENTIRE] district may be dissolved [ABOLISHED OR
10 ELIMINATED] if 60 percent of the resident owners and lessees of the
11 [CULTIVATED] land within the district who own or lease 30 percent of
12 the land within the district [OR THE AREA AFFECTED] petition for the
13 elimination or dissolution under [ABOLISHMENT, IN WHICH EVENT] the
14 procedure set out in this section for the establishment [FORMATION] of
15 a controlled livestock district [SHALL BE FOLLOWED FOR DISSOLUTION].

17 Sec. 03.35.030. NOTICE, HEARING, AND ORDER. Upon receipt of a
18 petition for the establishment, addition, elimination, or dissolution
19 of a controlled livestock district, the district judge shall set a
20 time for hearing the petition not less than 30 days after its receipt
21 [THEREAFTER]. Notice of the time and place of the hearing and its
22 purpose shall be posted in not less than three conspicuous public
23 places within the proposed district, including a post office, for a
24 period of at least 30 days before the hearing. If there is no post
25 office within the proposed district, then the notice shall be posted
26 in two conspicuous public places in the proposed district and in the
27 post office nearest the proposed district. If, at the hearing, the
28 district judge finds that the petition meets the requirements estab-
29 lished under AS 03.35.020 [IS SUFFICIENT] and that notice of the

1 hearing has been given, the district judge shall enter an order grant-
2 ing the request contained within the petition. The boundaries of the
3 district are those proposed within the petition [CREATING AND ESTAB-
4 LISHING THE CONTROLLED LIVESTOCK DISTRICT AND DESCRIBING ITS BOUND-
5 ARIES]. The district judge shall certify to the clerk of the superior
6 court for the judicial district a copy of the findings and order. The
7 district judge shall send a copy of the order to the commissioner of
8 natural resources [DIRECTOR, DIVISION OF AGRICULTURE, DEPARTMENT OF
9 NATURAL RESOURCES].

11 Sec. 03.35.035. IDENTIFICATION OF DOMESTIC ANIMALS WITHIN CON-
12 TROLLED LIVESTOCK DISTRICT. (a) Within 60 days of the establishment
13 of a controlled livestock district or of the addition to an estab-
14 lished controlled livestock district under AS 03.35.010, the person
15 having custody and control of domestic animals located within the
16 district shall identify the animals under AS 03.40, use identification
17 collars to indicate ownership, or otherwise use a reliable system for
18 the identification of the ownership of the animal.

19 (b) A person who violates (a) of this section commits a viola-
20 tion.

22 Sec. 03.35.040. LIABILITY FOR DAMAGES, AND LIEN. (a) The owner
23 of land within a controlled livestock district, whether the land is
24 fenced or unfenced, [(1)] is entitled to recover, from the owner or
25 person having custody and control of a domestic animal, for any injury
26 done by the animal [IT] when grazing or running at large within a
27 controlled livestock district contrary to the provisions of this
28 chapter, and [(2)] has a lien upon the domestic animal for the amount
29 of the damage done.
