6 \* Section 1. FINDINGS. The legislature finds that

7 (1) waste reduction and recycling must be a fundamental part of a comprehensive solid  
8 waste management effort;

9 (2) the success of waste reduction and recycling initiatives is largely dependent upon the  
10 current and future behavior of consumers in the state; and

11 (3) while significant opportunities for waste reduction and recycling exist, public  
12 education is required to ensure that consumers are aware of these opportunities.

14 Sec. 46.03.045. PUBLIC RECOGNITION OF POLLUTION PREVENTION EFFORTS.

15 In addition to the school awards program under AS 46.11.070, the department may identify,  
16 document, and publicly acknowledge exemplary pollution prevention achievements by individuals,  
17 businesses, or government agencies in the state.

19 Sec. 46.11.070. WASTE REDUCTION AND RECYCLING AWARDS FOR SCHOOLS.

20 (a) In consultation with the Department of Education, the Department of Environmental  
21 Conservation shall establish a waste reduction and recycling awards program under which the

1 Department of Environmental Conservation may annually, subject to available funding, award  
2 grants of up to \$2,000 each to public schools in recognition of their efforts and the efforts of  
3 their students to reduce and recycle waste generated in the administrative offices, classrooms,  
4 laboratories, cafeterias, and maintenance operations of the schools.

5 (b) The Department of Environmental Conservation shall, on request, provide technical  
6 assistance to schools concerning their opportunities to reduce and recycle wastes.

7 (c) The Department of Environmental Conservation shall adopt regulations to implement  
8 the awards program. For purposes of evaluating school waste reduction and recycling programs,  
9 the department may group schools according to geographical location, student population,  
10 distance to recycling markets, or other criteria considered appropriate by the department.

11 (d) The Department of Environmental Conservation may accept and use restricted grants  
12 of money or other assistance from private persons or groups to fund the awards made under (a)  
13 of this section.

14 (e) The Department of Environmental Conservation may not use state money to fund  
15 awards made under (a) of this section unless an appropriation is made specifically for the  
16 purposes of (a) of this section.
