TO: Users of the 1991 Session Laws of Alaska

Under the authority of AS 01.05.031, the revisor of statutes has renumbered certain Alaska Statutes provisions appearing in the 1991 Session Laws of Alaska to conform to the arrangement of the Alaska Statutes, to maintain a logical organization of the statutes, and to resolve multiple amendments to particular provisions. The numbering found in SLA chapters and the numbering that will appear in the fall 1991 supplements to the Alaska Statutes are shown below.
