Merging certain departments in the executive branch of state government; changing the names of certain departments in the executive branch of state government; transferring duties among departments and offices in the executive branch of state government; providing that certain discretionary duties formerly performed by the Department of Community and Regional Affairs are mandatory in the department to which those duties are transferred; relating to the licensing of child care facilities; relating to the division of vocational rehabilitation; relating to the Alaska Human Resource Investment Council; adjusting the membership of certain multi-member bodies; providing that a certain commissioner may designate department employees to serve in the commissioner's place on a board, council, or similar entity; providing for advice to be given by a department head to the governor and other commissioners on the delivery of government services to rural areas and providing for recommendations to be made to the governor and other commissioners by that same commissioner about policy changes that would affect rural governments and rural affairs; relating to the federal community development quota program; eliminating references to the division of tourism; eliminating a reference to manpower training programs; eliminating references to the director and deputy director of international trade; eliminating the requirement for a local advisory committee for consideration of rural electrification loans; and providing for an effective date.

5 **Sec. 14.37.005. Purpose; applicability.** (a) The purpose of this chapter is
6 to establish and maintain standard levels for services offered to children in child care
7 facilities. The legislature recognizes the responsibility of parents to select and monitor
8 caregivers for their children in order to ensure a reasonably safe and developmentally
9 appropriate child care environment. The child care licensing procedures in this chapter
10 are intended to reduce predictable risk of harm to children and to provide support
11 services to those providing child care services.

12 (b) This chapter and regulations adopted under this chapter apply to facilities

13 (1) for which licensure is required by or under AS 14.37.015; or

14 (2) that are exempt under AS 14.37.015 from licensure but for which
15 a license is issued under AS 14.37.015(c).

16 **Sec. 14.37.010. Powers of department.** (a) The department may

17 (1) license and supervise child care facilities;

18 (2) investigate applicants, licensees, and persons that the department
19 reasonably believes are operating a facility without a license or certification in
20 violation of this chapter;

21 (3) adopt regulations to implement the provisions of this chapter,
22 including regulations establishing certification and licensure procedures, standards, and
23 fees; establishing requirements for operation of facilities licensed under this chapter;
24 and distinguishing between types of child care facilities;

25 (4) enter into agreements with private entities, municipalities, or
26 individuals to investigate and make recommendations to the department for the
27 licensing and supervision of child care facilities under procedures and standards of
28 operation established by the department.

29 (b) The department shall, within 90 days after receiving a written request that
30 it do so, delegate its powers relating to child care facilities under this chapter to a
31 municipality that has adopted an ordinance providing for child care licensing under

2 29.35.210. A municipality to which these powers have been delegated may adopt, by
3 ordinance, additional requirements for child care facilities operating within its
4 boundaries if the requirements meet or exceed the requirements adopted by the
5 department.

6 **Sec. 14.37.015. License required; exemptions.** (a) A person may not operate
7 a child care facility without a license issued under this chapter unless that facility is
8 exempt from licensure. The following facilities are exempt:

9 (1) a facility in which child care is regularly provided and each child's
10 parent is on the premises within reasonable proximity and accessibility to the child;

11 (2) a facility located on a United States Department of Defense or
12 United States Coast Guard installation that is located on federal property;

13 (3) a recreational program that children are allowed to attend and in
14 which the program assumes no responsibility for care of the children;

15 (4) a daytime therapeutic program of supervised, educational, and
16 rehabilitative services for children with special needs or behavioral problems;

17 (5) a program that is primarily educational and that

18 (A) is certified as a pre-elementary school under department
19 regulations adopted under AS 14.07.020;

20 (B) serves children three years of age or older and is exempt
21 from the department pre-elementary school regulations; or

22 (C) is operated as a headstart preschool that is required to meet
23 the standards established under 42 U.S.C. 9836a;

24 (6) a temporary facility providing care for less than five continuous
25 weeks;

26 (7) a facility regularly providing child care to four or fewer children
27 unrelated to the caregiver;

28 (8) a facility in which the caregiver is a relative of all of the children.

29 (b) In addition to facilities that, under this section, are exempt from licensure,
30 the department, by regulation, may provide for additional exemptions that the
31 department considers appropriate.

1 (c) A person may apply for a license for a facility that is exempt from
2 licensure under this section. The department may issue a license to an applicant under
3 this subsection if the applicant meets the requirements of this chapter and regulations
4 adopted under this chapter.

5 **Sec. 14.37.017. Application for license.** (a) Application for a license to
6 operate a child care facility must be made to the department on a form provided by
7 the department and must be accompanied by all applicable fees established by the
8 department under AS 14.37.010(a)(3).

9 (b) An application submitted under this section must contain at least the
10 following information:

11 (1) the name and address of the applicant and, if the applicant is a
12 corporation, partnership, association, or another form of organization, the name,
13 address, and title of each individual who has an ownership or management interest in
14 the facility; if the applicant is an individual, the application must include the name,
15 age, and driver's license number, if any, of each member of the individual's
16 household;

17 (2) the name, physical location, and mailing address of the facility for
18 which the license is sought;

19 (3) the name and address of the administrator of the facility, if any;

20 (4) evidence that the administrator is an adult with sufficient
21 experience, training, or education to fulfill the duties of an administrator;

22 (5) a release for the administrator and for each other person who is 16
23 years of age or older, as specified by the department by regulation, who will have
24 contact with individuals served by the facility authorizing the department to review all
25 federal, state, and municipal criminal justice information, whether of this state, of a
26 municipality of this state, or of another jurisdiction, medical records, licensing records,
27 and protective services records, identified in regulations adopted under this chapter,
28 that are relevant to the person who is the subject of the release;

29 (6) the number of individuals that will be served in the facility;

30 (7) the type of facility for which the license is sought;

31 (8) copies of all inspection reports and approvals required by state fire

1 prevention and environmental health and safety authorities for operation of the facility,
2 including any variances granted by these authorities;

3 (9) a plan of operation, as required by the department by regulation;

4 (10) a staffing plan that describes the number of people who will work
5 at the facility, staff qualifications, a description of each person's responsibilities, and
6 a supervision schedule for the children in care that meets the requirements established
7 by the department by regulation;

8 (11) evidence that the applicant has completed orientation or training
9 required by the department by regulation; and

10 (12) other information required by the department, by regulation, in
11 order to monitor compliance with this chapter and regulations adopted under this
12 chapter.

13 **Sec. 14.37.020. Provisional license; biennial license.** (a) The department
14 shall issue a provisional license to a new facility that applies under AS 14.37.017 if,
15 after inspection and investigation, the department determines that the application and
16 plan of operation for the facility meet the requirements of this chapter and regulations
17 adopted under this chapter. A provisional license is valid for a period not to exceed
18 one year. The department may extend a provisional license for one additional period
19 not to exceed one year.

20 (b) Before expiration of a provisional license issued under (a) of this section,
21 the department shall inspect and investigate the facility in order to determine whether
22 the facility is operating under the provisional license in compliance with this chapter
23 and applicable regulations.

24 (c) Before expiration of a provisional license, the department shall issue a
25 biennial license for the facility if (1) after inspection and investigation under (b) of this
26 section, the department finds that the facility is operating in compliance with and
27 meets the licensure requirements of this chapter and regulations adopted under this
28 chapter; (2) none of the grounds for revocation set out in AS 14.37.130(a)(2) exist; and
29 (3) all applicable fees have been paid. The department shall prepare a summary report
30 of its findings and recommendations for issuance of a biennial license.

31 (d) The issuance of a license by the department does not obligate the

1 department to support the facility financially.

2 **Sec. 14.37.025. Denial of license; right to appeal.** (a) If the department
3 denies an application for a license or decides not to issue a biennial license, the
4 department shall hand deliver to the prospective licensee, or mail to the prospective
5 licensee by certified mail, return receipt requested, a notice of denial of licensure. The
6 notice must contain a summary of the department's reasons for denial of the license
7 and a form for requesting a hearing under (b) of this section.

8 (b) A prospective licensee who was denied licensure may appeal the
9 department's decision by requesting a hearing, on the form provided by the
10 department, within 15 days after receipt of the notice of denial of licensure.

11 **Sec. 14.37.027. Variances.** (a) The department may grant to an applicant for
12 a license under this chapter, or to a licensee, a variance from a requirement of this
13 chapter or a regulation adopted under this chapter if that person submits to the
14 department, on a form provided by the department, a complete variance request as
15 required by this section. A variance may be granted if

16 (1) the applicant or licensee proposes an alternative means, acceptable
17 to the department, to satisfy the intent of the requirement for which the variance is
18 requested; and

19 (2) the health and safety of children is adequately protected.

20 (b) A request for a variance must contain the following information:

21 (1) the statute or regulation from which the variance is sought;

22 (2) the reasons why the variance is needed;

23 (3) the period of time for which the variance is requested;

24 (4) the proposed alternative means of satisfying the intent of the
25 requirement for which the variance is requested;

26 (5) a statement as to how the health and safety of children will be
27 protected during the period of the variance; and

28 (6) assurance that the conditions of the facility do not present an
29 imminent danger to the health or safety of individuals served by the facility.

30 (c) To evaluate a request for a variance, the department shall take one or more
31 of the following actions:

- 1 (1) investigate the statements in the request;
2 (2) inspect the facility;
3 (3) schedule a conference with the applicant or licensee regarding the
4 variance request.

5 (d) The department's decision approving or denying a variance must be in
6 writing, and the department shall provide a copy of the decision to the person
7 requesting the variance. If the department grants the variance, the decision must state
8 the term of and conditions of the variance.

9 (e) If an applicant or licensee violates a condition of a variance granted under
10 this section, the variance is terminated.

11 **Sec. 14.37.029. Content of license; posting.** (a) A license issued under this
12 chapter must state

- 13 (1) the period of time during which the license is in effect;
14 (2) the name of the facility;
15 (3) the type of facility;
16 (4) the name of the licensee;
17 (5) the location and mailing address of the facility;
18 (6) the number and age range of children that the facility may have in
19 care at any time;
20 (7) all conditions set by the department;
21 (8) variances approved by the department for the duration of the
22 license; and

23 (9) the address and phone number of the nearest department office that
24 is responsible for administering this chapter or of the department representative
25 responsible for evaluating that facility under AS 14.37.010(a)(4).

26 (b) A licensee shall post the license in a conspicuous place in the facility,
27 visible to individuals in care and their families and to facility staff. If the department
28 has approved a variance that is not stated on the license, the licensee shall post a copy
29 of the variance near the license.

30 **Sec. 14.37.033. Licenses not transferable.** A license may be issued under
31 this chapter only for the location and person named in the application. A license

1 issued under this chapter may not be transferred to another person or location.

2 **Sec. 14.37.037. Orientation and training.** The department, by regulation,
3 may require that an applicant or licensee complete orientation or training to assist that
4 person in operating under the license.

5 **Sec. 14.37.039. Records required.** (a) In accordance with regulations
6 adopted by the department, a licensee shall keep the records regarding each individual
7 in its care that are necessary to show compliance with this chapter and regulations
8 adopted under this chapter.

9 (b) The department's licensing records, with the names of all individuals in
10 care and parents of minors in care deleted to protect the confidentiality of those
11 individuals, are available for public inspection, except for

12 (1) material made confidential by state or federal statutes or regulations;
13 (2) material that is part of an uncompleted licensing or complaint
14 investigation;

15 (3) records that would deprive an applicant, licensee, or other person
16 of a fair and impartial hearing; and

17 (4) records for which the department determines that disclosure would
18 constitute an unwarranted invasion of personal privacy.

19 (c) A government agency that provides funding to a facility licensed under this
20 chapter may have access to that facility's records in order to conduct an audit.

21 **Sec. 14.37.043. Monitoring; investigation.** (a) By the first anniversary of
22 the effective date of a biennial license, including a renewed biennial license, the
23 licensee shall submit an annual self-monitoring report to the department. The
24 department shall specify, by regulation, the contents of the report.

25 (b) To encourage parents of children in child care facilities to become involved
26 in day-to-day monitoring of the care provided by the facilities, the department shall
27 require licensees to give to parents of children in child care in the licensee's facility
28 a summary of the regulatory requirements that apply to the facility and the
29 department's or department representative's telephone contact number for reporting a
30 concern regarding child care. The department also may provide notice of the
31 telephone contact numbers for reporting child care concerns.

1 (c) The department may conduct an investigation, including announced or
2 unannounced on-site inspections, for ongoing monitoring or to assist in its review of
3 an annual self-monitoring report.

4 **Sec. 14.37.045. Biennial license renewal.** (a) At least 90 days before the
5 expiration date of a biennial license, a licensee who wishes to remain licensed shall
6 submit, on a form provided by the department, an application for renewal of the
7 license and any associated variances.

8 (b) Before expiration of a biennial license, the department or its representative
9 shall inspect a facility that is the subject of a renewal application.

10 (c) The department shall renew a biennial license if the department finds that

11 (1) the licensee

12 (A) either is in compliance with this chapter and regulations
13 adopted under this chapter or is substantially in compliance and has
14 implemented a plan of correction, approved by the department, that is designed
15 to bring the facility into full compliance; and

16 (B) has maintained the facility in good repair and is in
17 compliance with all state fire safety and environmental health and safety code
18 requirements;

19 (2) the ground for revocation set out in AS 14.37.130(a)(2) does not
20 exist; and

21 (3) all applicable fees have been paid.

22 (d) If the licensee submits a renewal application within the time period
23 required by the department by regulation, but the department is unable to complete its
24 review before the expiration date of the biennial license, the license is automatically
25 extended for six months or until the department completes its review and either
26 approves or denies the application, whichever occurs first.

27 (e) If the department decides to approve an application for renewal, but finds
28 that the applicant is not in compliance with a provision of this chapter, a regulation
29 adopted under this chapter, or a condition on the license, the department, as a
30 condition on the renewed biennial license, shall require the applicant to correct any
31 violations and provide the department with verification of compliance.

1 (f) If the department denies an application for renewal, it shall provide the
2 applicant with a notice of denial of application. The notice must contain a written
3 statement of the reasons for denial and a form for requesting a hearing under (g) of
4 this section.

5 (g) An applicant whose application is denied may appeal the department's
6 decision, on the form provided by the department, by requesting a hearing within 15
7 days after receipt of the notice of denial of application.

8 **Sec. 14.37.047. Notice of changes.** (a) A licensee shall provide the
9 department with written notice of a change of mailing address at least 14 days before
10 the effective date of the change.

11 (b) A licensee shall notify the department within 24 hours after having
12 knowledge of a conviction or indictment, presentment, or charging by information or
13 complaint of an administrator, regular volunteer, staff person, or member of the
14 licensee's household for a violation of the following laws or the laws of another
15 jurisdiction with similar elements:

- 16 (1) offenses against the family and vulnerable adults under AS 11.51;
17 (2) perjury under AS 11.56.200;
18 (3) offenses included in the definition of "serious offense" under
19 AS 12.62.900.

20 (c) A licensee shall notify the department at least 20 days before the effective
21 date of a decision to relinquish the license.

22 (d) A licensee shall notify the department at least 20 days before the date on
23 which the licensee wishes to change the number of children in care or hours of
24 operation.

25 (e) A licensee shall notify the department no later than one day after signing
26 a contract for sale of the licensed facility.

27 (f) A licensee shall notify the department at least 30 days before the licensee
28 wishes to change the location of the facility.

29 **Sec. 14.37.105. Complaints.** (a) A person who believes that a provision of
30 this chapter, a regulation adopted under this chapter, or a condition of a license issued
31 under this chapter has been violated may file a verbal or written complaint with the

2 (b) The department shall investigate all complaints filed under this section
3 unless the department reasonably concludes that the complaint is without merit.

4 (c) After an investigation under this section, the department shall prepare a
5 written report of investigation and shall mail a copy to the licensee or other person
6 who is the subject of the complaint, and to the complainant if requested. If the
7 department determines that a violation of this chapter, a regulation adopted under this
8 chapter, or a condition of a license issued under this chapter has occurred, the
9 department's report of investigation must contain the following:

10 (1) a description of the violation;

11 (2) a citation to the provision of this chapter or the regulation that has
12 been violated, if applicable; and

13 (3) either

14 (A) a date by which the violation must be corrected and a
15 verification of compliance submitted to the department; or

16 (B) a plan of correction.

17 (d) A licensee may submit to the department a written response regarding a
18 report of investigation relating to that facility. The department shall retain the written
19 response in the licensing file.

20 (e) A licensee may not take retaliatory action against a person who files a
21 complaint. A complainant against whom retaliatory action has been taken may recover
22 treble damages in a civil action upon a showing that the action was taken in retaliation
23 for the filing of a complaint.

24 **Sec. 14.37.110. Investigations; search warrants.** (a) An applicant for a
25 license, or a licensee, shall cooperate with the department for purposes of licensing
26 investigations, investigations relating to ongoing monitoring of the facility, or
27 investigations under AS 14.37.105 by

28 (1) permitting representatives of the department to inspect the facility,
29 review records, interview staff, and interview individuals in care; and

30 (2) providing to the department information and documentation
31 requested by the department to determine compliance with this chapter and regulations

1 adopted under this chapter.

2 (b) Following an investigation relating to ongoing monitoring of a facility or
3 relating to a facility that the department believes is operating without a license in
4 violation of this chapter, the department shall prepare and distribute a written report
5 of investigation as described in AS 14.37.105(c), and the facility may submit a
6 response as described in AS 14.37.105(d).

7 (c) The department may seek a search warrant to inspect a facility if

8 (1) the department has probable cause to believe that the facility is
9 operating without a license in violation of this chapter and the facility operator refuses
10 to allow an inspection by the department; or

11 (2) the licensee refuses to allow an inspection of the facility by the
12 department.

13 **Sec. 14.37.120. Enforcement actions.** (a) During an investigation under this
14 chapter, the department may, by written notice, suspend operations of the facility if the
15 department has reasonable cause to believe that a violation is occurring that presents
16 an imminent danger to the health or safety of the individuals in care. A suspension
17 under this subsection continues for the time period set by the department and may
18 continue until the department issues a report of investigation under AS 14.37.105(c)
19 or 14.37.110(b).

20 (b) If, after an investigation under this chapter, the department has determined
