22                   (3) has passed a written examination approved by the board that is  
23 designed to test the applicant's knowledge of the laws of Alaska governing the practice  
24 of optometry and the regulations adopted under those laws;

25                   (4) holds a current license to practice optometry in another state or  
26 territory of the United States or in a province of Canada;

27                   (5) at some time in the past, received a license to practice optometry  
28 from another state or territory of the United States or from a province of Canada that

19 satisfactory completion of continuing education requirements established by the board
