AN ACT

Designating Kinzarof Lagoon as part of the Izembek State Game Refuge; authorizing a land exchange with the federal government in which state land adjacent to the Izembek National Wildlife Refuge and within the Alaska Peninsula National Wildlife Refuge is exchanged for federal land to serve as a road corridor through the Izembek National Wildlife Refuge and federal land located on Sitkinak Island; and providing for an effective date.

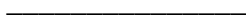
BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

AN ACT

1 Designating Kinzarof Lagoon as part of the Izembek State Game Refuge; authorizing a land
2 exchange with the federal government in which state land adjacent to the Izembek National
3 Wildlife Refuge and within the Alaska Peninsula National Wildlife Refuge is exchanged for
4 federal land to serve as a road corridor through the Izembek National Wildlife Refuge and
5 federal land located on Sitkinak Island; and providing for an effective date.

7 * **Section 1.** The uncodified law of the State of Alaska is amended by adding a new section
8 to read:

9 PURPOSE. In accordance with P.L. 111-11 (Omnibus Public Land Management Act
10 of 2009), the purposes of this Act are to

11 (1) add state land and water within and adjacent to Kinzarof Lagoon near Cold
12 Bay to the Izembek State Game Refuge; and

13 (2) authorize the Department of Natural Resources to exchange land near Cold
14 Bay and on Sitkinak Island near Kodiak with the federal government.

26 * **Sec. 4.** The uncodified law of the State of Alaska is amended by adding a new section to
 27 read:

28 EXCHANGE OF STATE LAND FOR FEDERAL LAND. (a) Notwithstanding any
 29 other provision of law, the Department of Natural Resources shall convey all right, title, and
 30 interest of the state to certain land adjacent to the Izembek National Wildlife Refuge,
 31 described as Township 53 South, Range 85 West, Seward Meridian, and Township 54 South,

1 Range 85 West, Seward Meridian, and totaling 43,000 acres more or less, to the federal
2 government in exchange for federal land conveyed to the state. The federal land expected to
3 be received in the exchange is described in (b) of this section.

4 (b) The land expected to be received from the federal government is

5 (1) all right, title, and interest in 206 acres more or less of federal land located
6 within the Izembek National Wildlife Refuge for the purpose of a corridor for the construction
7 and operation of a road between the communities of King Cove and Cold Bay, Alaska, in
8 accordance with P.L. 111-11 (Omnibus Public Land Management Act of 2009), described as
9 follows:

25 (c) The construction and operation of the road described in (b)(1) of this section is
26 authorized after the state receives the land described in (b)(1) of this section in accordance
27 with P.L. 111-11 (Omnibus Public Land Management Act of 2009).

28 * **Sec. 5.** The uncodified law of the State of Alaska is amended by adding a new section to
29 read:

30 EXCHANGE OF LAND NOT SUBJECT TO AS 38.50. The exchange of state land
31 under sec. 4 of this Act is not subject to AS 38.50, including any requirement that relates to

1 the valuation or equalization of land.

2 * **Sec. 6.** The uncodified law of the State of Alaska is amended by adding a new section to
3 read:

4 EFFECT OF VOIDED LAND EXCHANGE. If the land exchange authorized by sec.
5 6402(a), P.L. 111-11 (Omnibus Public Land Management Act of 2009) is null and void under
6 sec. 6405, P.L. 111-11 (Omnibus Public Land Management Act of 2009),

7 (1) the land added to the Izembek State Game Refuge under sec. 2 of this Act
8 and removed under sec. 3 of this Act shall be returned to its land management status in effect
9 before the enactment of sec. 2 of this Act; and

10 (2) the land conveyed by the state under sec. 4 of this Act shall be returned to
11 its ownership status as it existed before the conveyance.

12 * **Sec. 7.** The uncodified law of the State of Alaska is amended by adding a new section to
13 read:

14 CONDITIONAL EFFECT AND NOTIFICATION. (a) Sections 1, 2, 4, and 5 of this
15 Act take effect only if the United States Secretary of the Interior determines that the land
16 exchange described in sec. 4 of this Act is in the public interest under secs. 6401 - 6406, P.L.
17 111-11 (Omnibus Public Land Management Act of 2009). The commissioner of natural
18 resources shall notify the lieutenant governor and the revisor of statutes of the determination
19 and the date of the determination by the United States Secretary of the Interior described in
20 this subsection.

21 (b) Sections 3 and 6 of this Act take effect only if the land exchange authorized by
22 sec. 6402(a), P.L. 111-11 (Omnibus Public Land Management Act of 2009) is null and void
23 under sec. 6405, P.L. 111-11 (Omnibus Public Land Management Act of 2009). The
24 commissioner of natural resources shall notify the lieutenant governor and the revisor of
25 statutes if the land exchange authorized by sec. 6402(a), P.L. 111-11 (Omnibus Public Land
26 Management Act of 2009) is null and void under sec. 6405, P.L. 111-11 (Omnibus Public
27 Land Management Act of 2009) and of the date on which the land exchange is null and void.

28 * **Sec. 8.** If secs. 1, 4, and 5 of this Act take effect under sec. 7(a) of this Act, they take
29 effect on the date the United States Secretary of the Interior determines the land exchange is
30 in the public interest under sec. 6402, P.L. 111-11 (Omnibus Public Land Management Act of
31 2009).

1 * **Sec. 9.** If sec. 2 of this Act takes effect under sec. 7(a) of this Act, it takes effect on the
2 date the exchange of land described in sec. 4 of this Act is executed by the Department of
3 Natural Resources and the United States Department of the Interior. The commissioner of
4 natural resources shall notify the lieutenant governor and the revisor of statutes of the date the
5 exchange of land is made.

6 * **Sec. 10.** If secs. 3 and 6 of this Act take effect under sec. 7(b) of this Act, they take effect
7 on the date the land exchange authorized by sec. 6402(a), P.L. 111-11 (Omnibus Public Land
8 Management Act of 2009) is null and void under sec. 6405, P.L. 111-11 (Omnibus Public
9 Land Management Act of 2009).

10 * **Sec. 11.** Except as provided in secs. 8 - 10 of this Act, this Act takes effect immediately
11 under AS 01.10.070(c).
